Enhancements

Phase Field and Category Field Message Displays When No Data is Available

After selecting a job in the **Job** field, a message prompt now displays for the following conditions:

- When the **Phase** field is required, but a phase code is unavailable
- When the **Phase** field is required with an available code and the **Category** field is required, but a category code is unavailable
- When the **Category** field is required, but a category code is unavailable

ComputerEase Time Center Approver Information for Users that Signed the Automatically Approved ComputerEase Field Time Entries

On the Time Center window (**Payroll System » Time Center**) of ComputerEase, the user that signed the ComputerEase Field time entries that are automatically approved are now specified as the approver in the Approver column.

ComputerEase Field time entries that are automatically approved are time entries that have no jobs charged or the jobs charged do not have an approval team assigned.

Signatures with All Entries Edited to be Resigned are Now Removed from View in ComputerEase Field

Signatures for edited time entries that require a new signature will now no longer show to the user. This applies to time entries that were:

- Rejected and edited
- Edited by the user after signing

Summary of Changes

Software Issues Resolved

The following is a list of software issues resolved for this release:

- **Merchant** Field not Truncating to 30 Characters when using Verifyfi for Receipt
- Users Without Allow Multiple Employee Entries Setting Able to View Other Entries
- Users Using a Hyphen in their Email Addresses Unable to Log In
- No Logical Sort in **Select Employees** Field on Add Time Entry Screen
- Auto Advance New Entries Not Working on Add Time Entry Screen from GPS Tracking Notification
- Options in Worker Class Field Displayed Incorrectly on Add Time Entry Screen

Software Issues Resolved

This section includes software issues resolved in this release.

Options in Worker Class Field Displayed Incorrectly on Add Time Entry Screen

Defect 1994429: The options in the **Worker Class** field on the Add Time Entry screen were displayed incorrectly. This applied to options with longer descriptions and did not fit in the list of options displayed.

Merchant Field not Truncating to 30 Characters when using Verifyfi for Receipt

Defect 2002025: When you attached and submitted a receipt with more than 30 characters using Verifyfi, the **Merchant** field did not truncate to the maximum character limit of 30.

Users Using a Hyphen in their Email Addresses Unable to Log In

Defect 2004603: Users using a hyphen in their email addresses were unable to log in to ComputerEase Field. When these users tapped **Get Started**, the button was unresponsive.

Users Without Allow Multiple Employee Entries Setting Able to View Other Entries

Defect 2009716: Users without the Allow Multiple Employee Entries Setting enabled from ComputerEase were able to view other employee entries on the Time screen of ComputerEase Field.

No Logical Sort in Select Employees Field on Add Time Entry Screen

Defect 2014030: The options in the Select Employees field on the Add Time Entry screen were not displayed in logical sort.

Auto Advance New Entries Not Working on Add Time Entry Screen from GPS Tracking Notifications

Defect 2014155: When you were filling out fields on the Add Time Entry screen from a GPS tracking notification, you were auto-advanced to fields already filled out instead of being auto-advanced to empty fields.
