Description: Several changes have been made to the Manage Work Assignments application, as follows:

- A new subtask, PO Info, is added to this screen to allow you to view general information, cost amounts, and other additional information on the purchase order (PO) lines linked to the PO associated with the work assignment. This has the following subtasks:
 - Line Charges - Use this subtask to view additional charges for the item associated with the PO line linked to the work assignment purchase order.
 - PO Line Accounts - Use this subtask to view project/account/organization information for the PO line linked to the work assignment purchase order.
 - PO Line Resources/Vendor Employees - Use this subtask to view details of the resources associated with the PO line linked to the work assignment purchase order. This has the Vendor Employees subtask, where you can view information on vendor employees associated with the resource line.
- New options added to the Charges subtask allow you to specify settings in automatically loading charge lines. In loading PO lines as charge lines, you now have options to load PO line charges and/or PO line resources. You can also load charge lines for work force projects, and load vendor employees in the work force for all project labor categories (PLCs) or just those with default PLCs. In addition, you can specify if the system should use the organization from the PO or the project owning organization in loading charge lines.
- Also on the Charges subtask, the warning message (shown upon approval of a charge line) indicating that the Amount Before Discount value must be greater than zero has been removed. Costpoint now allows companies to have zero hours and amounts on the charge lines and vendor employee lines.
- The Vendor Employees subtask of the Charges subtask is also updated to give you options to load vendor employees in the work force for all PLCs or just those with default PLCs. In addition, the **Approval Status** drop-down list now includes **Removed from work force**. You can select this status, or this status automatically displays when the vendor employee record has been removed using the Manage Vendor Employee Work Force application.

Customers Impacted: These enhancements affect clients who are funding at the PO project level and want to track charges at a lower project level.
