Description: The application did not truncate values with more than 9 characters in the **Transmitter Federal EIN** field (positions 6-14 on A, B, and E Records). In addition, if the **Transmitter Federal EIN** field value was less than 9 characters, the next field in the record immediately occupied the next positions that are still designated for the **Transmitter Federal EIN** field value (positions 6-14). As a result of these issues, if the **Transmitter Federal EIN** field value was not exactly 9 characters, the positions of subsequent fields in the record were incorrect.

Customers Impacted: This defect affects Costpoint Payroll users.

Workaround Before Fix: Ensure that the value in **Tax ID** field on the Configure Company Information screen is equal to 9 characters.

Description: When you create a quarterly SUTA tax file for employees with Illinois as the SUTA state, the file should have zeroes in the following fields/positions on the **S** Record since they are not used by Illinois:

- State QTR Unemployment Insurance Excess Wages (Positions 78-91)
- State QTR Unemployment Insurance Taxable Wages (Positions 92-105)

Customers Impacted: This defect affects Costpoint users with employees that have Illinois as SUTA state.

Workaround Before Fix: Manually edit the fields/positions in the SUTA tax file.

Description: When you created a quarterly SUTA tax file for employees with Illinois as the SUTA state, the **F** (Final) Record contained zeroes in positions 125-139 instead of blanks in positions 125-276.

Customers Impacted: This defect affects Costpoint users with employees that have Illinois as SUTA state.

Workaround Before Fix: Manually edit the fields/positions in the SUTA tax file.
