#### VAT Included in IWOs and VAT Reporting

This enhancement will allow users to move sales tax and/or value-added tax (VAT) values through the intercompany work order (IWO) to the receiving company, and allow them to report those values on VAT reports and sales tax inquiries. This will also allow users to bill the end customer if they choose to. Several screens and reports in the Projects and Accounting domains are currently being updated for this enhancement.

#### 2019 Calendar Year End (CYE) Regulatory Updates – Part 1

Part 1 of 2019 CYE regulatory updates will be released in early December 2019. This includes enhancements for the following federal and state updates:

- Separate 1099 reporting for non-employee compensation
- USERRA make-up amounts for 2018 in W-2
- Massachusetts Paid Family and Medical Leave
- Oregon W-2 transit tax
