Description: When you added requisitions to existing purchase orders (PO), you received this message: "Warning: This PO already exists. A new line will be created. Requisition line buyer will be ignored." And when you saved the record, this error message appeared: "This PO/Rlse number has been assigned to either another buyer or vendor or address."

Customers Impacted: This defect affects Costpoint users.

Workaround Before Fix: None.

Additional Notes: The requisition line buyer should match the PO buyer and no conflicting messages of warning and error should appear.

Description: When you deleted a line charge in a rejected requisition and the record total was less than the approvers minimum/maximum amount, then you resubmitted it back for approval, Costpoint saved the record instead of validating the min/max amount and displaying an error message if the amount is not within the min/max limit.

Description: Duplicate COMM_CD in multi-company system caused default buyer error when Manage Commodity Codes (PDMCOMCD) screen saved the commodities under the correct company ID, but during retrieval on the Manage Purchase Requisitions (PPMNTRQ1) screen, the company ID was not considered.

Customers Impacted: This defect affects Costpoint users.

Workaround Before Fix: Double check commodities and buyer codes.
