**Description:** When the **Ceiling Method** is **Period and Year** and the employee's balance (beginning balance + YTD Accrued - YTD Used) is greater than the Period Balance Ceiling, the application should not adjust the employee's balance down to the ceiling amount. Instead, accrual should be zero. The employee should not accrue again until the balance goes below the Period Balance Ceiling. However, the balance should not be adjusted down to the Period Balance Ceiling amount.

**Description:** When calculating hours from D, N, RV, and C type timesheets, the application should use the Timesheet Date (TS\_DT) column, and not the Correction Reference Date (CORRECTING\_REF\_DT) column, on the Timesheet Header (TS\_HDR) table.
