New Features

This section includes new features in this release.

Timesheet Approvals

When this feature is enabled, you can now manage the time entries of employees as an approver in ComputerEase Field. On the Approvals screen, you can do the following to the signed entries of other employees:

- View time entries for approval by job or employee
- Approve or reject time entries
- Specify reasons for rejecting time entries
- Track details of time entries as changes are made

As a user with a time entry with a Pending, Signed, or Rejected status, you can still edit and sign your time entry to resubmit it for approval. You can also identify which time entries do not match your geofence arrival time based on the tolerance settings configured by your ComputerEase administrator.

Note: Time entries charged to jobs that have approval teams specified are available for approval in ComputerEase Field by the users set as approvers for that job. All other time entries will be automatically approved and sent to the Time Center in ComputerEase. Time entries that are automatically approved have a blank Approver column when viewed from the ComputerEase Time Center.

Rating Prompt for the App Store and Google Play Store

ComputerEaseField now sends users a prompt to rate the app on the App Store or Google Play.

Setting for Customizing the Default Starting Day of the Week

On the Settings screen, you can now select the default starting day of the week by using the **Select Starting Day of Week** field. This setting is reflected on the Time screen.

Setting for Viewing and Signing Time Entries Only in ComputerEase

In ComputerEase, you can now restrict ComputerEase Field users to view and sign time entries using the **View and Sign Only** checkbox. When a user has this checkbox selected for them, they can't add and edit time entries, but only view and sign time entries when logged into ComputerEase Field.

Enhancements

This section includes enhancements in this release.

Equipment Charge for Expenses

In the **Type** field on the Create Expense screen or Edit Expense screen, you can now select **Equipment** as an expense type. When you select **Equipment** in the **Type** field, the following required fields now display:

- **Equipment**
- **Equipment Code**

Note: You can also select **Fuel** and **Miscellaneous** in the **Type** field, but the **Equipment** and **Equipment Code** fields are optional.

The information you enter in these fields are then recorded in **Expense Management** of ComputerEase.

Note: ComputerEase version 23.2 or later is required.

Expanded Search Capabilities for Expense

When you perform a search on the Expense screen, you can now search for details found on the Expense Details screen of an expense including the added equipment and descriptions.

Automatic Default Selection of Phase and Category by Expense Type

When configured for an expense type in ComputerEase, options in the **Phase** field and **Category** field are now automatically selected by default after completing the **Job** field for a time entry or expense.

Access to Recently Used List for Time Entry or Expense

When your access is removed from ComputerEase, the relevant item you searched for previously is now removed from the recently used list in the following fields for a time entry or an expense:

- **Job**
- **Phase**
- **Category**
- **Equipment**
- **Equipment Code**

Table Control on Signature Certification Screen

On the Signature Certification screen, you can now scroll from left to right and vice versa with the first column of the relevant table staying in place for the following tabs:

- Day
- Job
- Employee

Software Issues Resolved

This section includes software issues resolved in this release.

ComputerEase Worker Class Filters Not Reflected in ComputerEase Field

Defect 2026177: When a worker class filter for union is configured in ComputerEase, the worker class options displayed in ComputerEase Field displayed both union and non-union worker classes.

View Rejected Button does not Display for Users with Rejected Time Entries

Defect 2042073: When you get a rejected time entry, the **View Rejected** button was not displayed on the Time screen.
