## Year-End Checklist

At year end, you need to complete the steps listed in the checklist below. You should complete all required activities in the recommended order.

Step	Description	Done?
1.	Verify that your overall financials are in balance by ensuring the Trial Balance Report Total is 0.	
2.	Reconcile Cash Accounts. The reconciled bank statement for the year should be completed. Use the reconciled bank statement for the year end you are reconciling to the Trial Balance.	
3.	Reconcile Accounts Receivable. Compare the Client Invoice Aging report to the Trial Balance report.	
4.	Reconcile Prepayments. Compare the Client Invoice Aging report to the Trial Balance report.	
5.	Reconcile Work-In-Progress accounts. Compare the Work-in-Progress Aging report to the Trial Balance report.	
6.	Reconcile Accounts Payable. Compare the Vendor Invoice Aging report to the Trial Balance report.	
7.	Reconcile Salaries Payable. Compare the Salaries Payable Balance report to the Trial Balance report.	
8.	(Optional) Reconcile Gross Wages for accrual accounting. Compare Gross Wages from the Check Activity Report minus In/Out Pays to All wage expense account amounts for the year to date plus Payroll Variance account amount for the year to date plus change in Salaries Payable for the year to date.	
9.	Make any Adjusting Entries currently known.	
10.	Close the Fiscal Year.	
11.	Update Ajera to the newest version to get current Government Forms.	
12.	Print or create e-files for W-2, 1099 MISC, and W-3 (follow specific checklists for these forms).
