## Overview

Welcome to Deltak Costpoint Mobile Time and Expense 2.0 Cumulative Update Release Notes. These release notes contain a summary of the following:

- New Features and Enhancements
- Software Issues Resolved

**Note:** The official name of the application is *Deltak Costpoint Mobile Time and Expense*. This document only uses it at first mention. The succeeding instances of the application name display *Costpoint Mobile T&E*.

In addition, the application name in the *Apple App Store* and *Google Play Store* displays *Costpoint Time and Expense*.

## Mobile Devices Requirements

The Costpoint Mobile T&E application supports mobile devices that run on the following operating systems:

- Apple iOS 12 and higher
- Android 8 and higher

## Prerequisites

**Attention:** Information in this section does not apply to Cloud customers.

Before you begin the installation and setup of Costpoint Mobile T&E, it is important to understand the following information:

- You must install Costpoint Time & Expense 10.x and Costpoint Maintenance Release 7.1.3, at the minimum.
- If you are going to access Costpoint Mobile T&E from the Internet, open a port in your firewall to access the Costpoint Time & Expense virtual directory, which will be installed on the IIS server. Costpoint Mobile T&E requires the use of TLS 1.2 protocol in production deployments and all installations when using mobile devices.
- You must install Costpoint Mobile T&E on an IIS Web server. You can use an existing IIS Web server or your Costpoint Web server, but not the embedded WebLogic Web server.

## Technical Considerations

You must meet the following requirements to run Costpoint Mobile T&E:

- You must install Costpoint Mobile T&E on an IIS server that is installed on Windows Server 2012 R2, Windows Server 2016, or Windows Server 2019.
- When using Secure Sockets Layer (SSL), you must have a certificate issued by a trusted certificate authority. You must not use self-signed certificates. Wild card certificates are acceptable if they come from a trusted certificate authority.

**Note:** Costpoint Mobile T&E supports applications from the Apple App Store and Google Play Store.

**Note:** The Costpoint Mobile T&E URL has the format **https://<server>/DeltekTouch/Costpoint/TE**, where **<server>** refers to the host name of your Costpoint Mobile T&E server.

**Note:** The Costpoint Mobile T&E installer installs PHP 7.4.15 in this release.

#### [Able to View or Edit Timesheet Periods Prior to Timesheet Class Effectivity Date](#)

Defect 1438932

**Description:** You could view or edit timesheet periods prior to a resource's timesheet class effectivity date.

**Customers Impacted:** This defect affects all Costpoint Mobile T&E users accessing timesheets.

**Workaround Before Fix:** None.

#### [Missing Expense Type When Editing and Saving an Expense Report with Combined Expense Type and Category](#)

Defect 1447851

**Description:** When editing an expense report with combined expense type and category, only the expense category was displayed after saving the expense report.

**Customers Impacted:** This defect affects all Costpoint Mobile T&E users editing expense reports with combined expense type and category.

**Workaround Before Fix:** None.

#### [Outstanding Expense Wizard Type Was Empty When Using Capture Receipt with Wizard Type Set to Other](#)

Defect 1452766

**Description:** If you set **Wizard Type** to **Other** when using the Capture Receipt feature, the **Wizard Type** field of the newly created outstanding expense was empty.

**Customers Impacted:** This defect affects all Costpoint Mobile T&E users using Capture Receipt with **Wizard Type** Set to **Other**.

**Workaround Before Fix:** None.

## Timesheet Hours Set to Hundredth Was Not Properly Displayed in Mobile

Defect 1460280

**Description:** The timesheet hours were not properly displayed in the Costpoint Mobile T&E application if the hours increment of your timesheet class was set to **Hundredth**.

**Customers Impacted:** This defect affects all Costpoint Mobile T&E users accessing timesheets.

**Workaround Before Fix:** None.

## Unspecified Error Encountered When Performing Timesheet Search

Defect 1463156

**Description:** When you performed a timesheet search after opening another timesheet period, you encountered an unspecified error.

**Customers Impacted:** This defect affects all Costpoint Mobile T&E users performing timesheet search.

**Workaround Before Fix:** None.

## Errors or Warnings Encountered When Accessing Timesheets

Defect 1465393

**Description:** When loading a missing timesheet for the current period or performing a search using Lookup Charges for an open timesheet, you encountered errors or warnings about the required fields.

**Customers Impacted:** This defect affects all Costpoint Mobile T&E users accessing timesheets.

**Workaround Before Fix:** None.

## Application Stopped Responding When Performing a search through Lookup Charges to Add a Charge

Defect 1476688

**Description:** When adding a charge by performing a search through Lookup Charges, the Costpoint Mobile T&E application stopped responding.

**Customers Impacted:** This defect affects all Costpoint Mobile T&E users creating expense reports.

**Workaround Before Fix:** None.

## Date Picker Displayed the Incorrect Date of Each Last Day of Every Month

Defect 1484323

**Description:** The date picker displayed the incorrect date of the last day of every month.

**Customers Impacted:** This defect affects all Costpoint Mobile T&E users.

**Workaround Before Fix:** None.

## Incorrect Weekly Summary Displayed for Timesheet Class Effectivity Date That Started During the Middle of a Timesheet Period

Defect 1489314

**Description:** If a resource's timesheet class effectivity date started during the middle of a timesheet period, the weekly summary displayed the hours for the incorrect week when approving the timesheet.

**Customers Impacted:** This defect affects all Costpoint Mobile T&E users accessing timesheets.

**Workaround Before Fix:** None.

## Error Encountered When Loading a Missing Timesheet Period

Defect 1489358

**Description:** When loading a missing timesheet period, you encountered the "cannot getTime() of undefined" error.

**Customers Impacted:** This defect affects all Costpoint Mobile T&E users accessing timesheets.

**Workaround Before Fix:** None.

## Hour Field Displayed Zero When Changing Your Timesheet View from Summary View to Day View

Defect 1489746

**Description:** When changing your timesheet view from Summary view to Day view, the hour field of the first day of the timesheet period displayed **0** value.

**Customers Impacted:** This defect affects all Costpoint Mobile T&E users accessing timesheets.

**Workaround Before Fix:** None.

## Incorrect Date Displayed in Day View When Tapped in Summary View

Defect 1490996

**Description:** When you tapped a date in Summary view, the correct date was not displayed in Day view.

**Customers Impacted:** This defect affects all Costpoint Mobile T&E users accessing timesheets on iOS devices.

**Workaround Before Fix:** None



## Application Got Stuck on Loading the Date in Summary View When Show Charge Detail in Day Summary Was Set to Off

Defect 1490997

**Description:** If **Show Charge Detail in Day Summary** was set to **Off** and you tapped a timesheet date in Summary view, the application got stuck on loading the date.

**Customers Impacted:** This defect affects all Costpoint Mobile T&E users accessing timesheets.

**Workaround Before Fix:** None.

## Known Issues

### Unable to Use Capture Receipt on iPhone 12 Pro Max

**Description:** You got logged out of the application when accessing Capture Receipt using iPhone 12 Pro Max.

**Customers Impacted:** This defect affects all Costpoint Mobile T&E users accessing Capture Receipt using iPhone 12 Pro Max.

**Workaround Before Fix:** None.

## Costpoint Mobile T&E 2.0 Cumulative Update 05

This cumulative update applies to Costpoint Mobile T&E application 2.0.7 and Costpoint Mobile T&E Server 2.0.7.

**Released:** April 16, 2021

#### Support for PHP 7.4.15

The Costpoint Mobile T&E Server has been upgraded to support PHP 7.4.15.

### Software Issues Resolved

This section includes summaries of the software issues resolved included for this release.

#### Unable to Load UDT10 Pay Type Embedded Under Charge Favorite on the Mobile Application

Defect 1394595

**Description:** UDT10 Pay Type embedded under Charge Favorites failed to load when selected from the Favorites Lookup Charges on the Costpoint Mobile T&E application. Instead, default charges loaded.

**Customers Impacted:** This defect affects all Costpoint Mobile T&E users using favorites with an embedded UDT10.

**Workaround Before Fix:** Allow UDT10 Lookup in the TS Class UDT10 settings.

**Additional Notes:** This is an issue on the Deltak Time & Expense application. The fix is included in Costpoint Maintenance Release 7.1.13 (Defect 1401890) and 8.0.5 (Defect 1402427).

#### System Error Encountered When Adding Charge Allocation to a Claimed Expense

Defect 1409009

**Description:** When you added a charge allocation to a claimed expense and then tried to add another charge again, you encountered a system error.

**Customers Impacted:** This defect affects all Costpoint Mobile T&E users adding charge allocation to a claimed expense.

**Workaround Before Fix:** None.

#### Image Cut Off When Viewing a Large Receipt Attachment

Defect 1415399

**Description:** When you viewed a large image of receipt attached to expense, the image was cut off.

**Customers Impacted:** This defect affects all Costpoint Mobile T&E users attaching receipts using Capture Receipt.

**Workaround Before Fix:** None.

## Inappropriate Message Displayed When Tapping an Attachment Row of an Expense Report

Defect 1418800

**Description:** Costpoint Mobile T&E displayed an inappropriate message when tapping an attachment row of an expense report. The message displayed as follows: "Please choose to attach an attachment or add a missing explanation".

**Customers Impacted:** This defect affects all Costpoint Mobile T&E users viewing attachments of an expense report.

**Workaround Before Fix:** None.

**Additional Notes:** The message now displays as follows: "Please select the row (click the checkmark) to take action upon the row."

## Timesheet Hours Edited on the Edit Charge Screen Not Reflected on the Timesheet Screen

Defect 1408295

**Description:** When you edited the Hours field of a timesheet line on the Edit Charge screen and then tapped **Done**, the changes were not reflected on the Timesheet screen.

**Customers Impacted:** This defect affects all Costpoint Mobile T&E users editing hours on the Edit Charge screen.

**Workaround Before Fix:** None.

## Issues Encountered on Timesheets with Missing Periods

Defect 1418024

**Description:** You encountered any of the following issues on timesheets with missing periods:

- When tapping the calendar icon, Costpoint Mobile T&E asked you to save the timesheet period even if you did not make any changes and then loaded the timesheet period again.
- When adding a new timesheet line, Costpoint Mobile T&E asked you to save the timesheet period but did not display the next timesheet period.

**Customers Impacted:** This defect affects all Costpoint Mobile T&E users editing a timesheet with missing periods.

**Workaround Before Fix:** None.

## Unable to Add Under Ceiling Charge Allocation Even If Configured in Costpoint

Defect 1420845

**Description:** You were unable to add an under ceiling charge allocation to an expense even if it was configured to be displayed for the expense type in Costpoint Time & Expense.

**Customers Impacted:** This defect affects all Costpoint Mobile T&E users adding charge allocation to a claimed expense.

**Workaround Before Fix:** None.

## Screen Display Responded Slowly After Tapping an Invalid Timesheet Charge in Favorites

Defect 1377432

**Description:** When you encountered an error after tapping an invalid timesheet charge in the Favorites list, the screen display responded slowly on Android devices.

**Customers Impacted:** This defect affects all Costpoint Mobile T&E users on Android devices.

**Workaround Before Fix:** None.

## Unable to Load Outstanding Expenses When ICR Was Set to Off

Defect 1385107

**Description:** If **Use ICR for Expenses** was set to **Off**, Costpoint Mobile T&E did not load the outstanding expenses when attaching a captured receipt to an existing expense report.

**Customers Impacted:** This defect affects all Costpoint Mobile T&E users.

**Workaround Before Fix:** None.

## Error Encountered When Tapping Approve Timesheets for Resource Manager with No Role Assigned to a Resource

Defect 1440271

**Description:** If you were a resource manager with no role assigned to a resource, you encountered the "Timesheets failed to load" error when tapping **Approve Timesheets** on the Tasks screen.

**Customers Impacted:** This defect affects all Costpoint Mobile T&E users.

**Workaround Before Fix:** None.

## Approval Text Not Displayed When Approving Timesheets Even If Configured in Costpoint

Defect 1452201

**Description:** When approving a timesheet, the approval text did not display even if it was configured in Costpoint Time & Expense.

**Customers Impacted:** This defect affects all Costpoint Mobile T&E resource managers approving timesheets.

**Workaround Before Fix:** None.

**Additional Notes:** This issue is encountered only in the Costpoint Mobile T&E 2.0.7 Beta version.

## Error Encountered When Approving a Single Timesheet

Defect 1450944

**Description:** When approving a single timesheet, you encountered a "TypeError" error.

**Customers Impacted:** This defect affects all Costpoint Mobile T&E resource managers approving a single timesheet.

**Workaround Before Fix:** None.

**Additional Notes:** This issue is encountered only in the Costpoint Mobile T&E 2.0.7 Beta version.

## Costpoint Mobile T&E 2.0 Cumulative Update 04

This cumulative update applies to Costpoint Mobile T&E application 2.0.6.

#### ICR Plugin Update

The intelligent character recognition (ICR) plugin for processing and data extraction has been updated to its latest version.

#### Meal Expense Type Configured With No Meal Options Now Treated as a Non-Meal Expense

Costpoint Mobile T&E now treats meal expense type that is configured with no meal options on the Meals Expense wizard as a non-meal expense type (for example, entertainment), allowing you to enter the expense details through the mobile application.

### Software Issues Resolved

#### Scrolling Issue Encountered on Devices Running on iOS 13

Defect 1397327

**Description:** When you scrolled through a list, tapped an item to view, and then returned to the list, you encountered a slow performance issue if you scrolled through the list again.

**Customers Impacted:** This defect affects all Costpoint Mobile T&E users with devices running on iOS 13.

**Workaround Before Fix:** None.

#### Able to Search and Add Charge Even If User Was Not Allowed to Perform these Actions

Defect 1397984

**Description:** You could still search and add a default charge code to an expense report even if you were not set up to search charge code.

**Customers Impacted:** This defect affects all Costpoint Mobile T&E users.

**Workaround Before Fix:** None.

## Expense Incurred Reset to Zero When Adding an Outstanding Expense

Defect 1398972

**Description:** When you changed the date while adding an outstanding expense an expense report, the **Expense Incurred** field on the Expense Details screen was reset to zero.

**Customers Impacted:** This defect affects all Costpoint Mobile T&E users.

**Workaround Before Fix:** None.

## Error Encountered When Adding a Provider to an Expense Report

Defect 1398973

**Description:** You encountered a "Provider does not exist" error when adding a provider to an expense report even if the provider did exist in the database.

**Customers Impacted:** This defect affects all Costpoint Mobile T&E users who use providers in their expenses.

**Workaround Before Fix:** None.

## Error Encountered When Loading Tasks

Defect 1383686

**Description:** You sometimes encountered a "Type Null" error when loading tasks.

**Customers Impacted:** This defect affects all Costpoint Mobile T&E users.

**Workaround Before Fix:** None.

## Weekly Summary View Displayed Zero Values When Timesheet Contained Non-Zero Hours

Defect 1397098

**Description:** The Week tab on the Summary screen displayed zero values even if the selected timesheets contained non-zero hours.

**Customers Impacted:** This defect affects all Costpoint Mobile T&E users.

**Workaround Before Fix:** None.

## Alert Did Not Display When Signing a Timesheet in Summary View

Defect 1395426

**Description:** When you signed a timesheet on the Summary view, the certification alert did not display.

**Customers Impacted:** This defect affects all Costpoint Mobile T&E users.

**Workaround Before Fix:** None.

## Timesheet Detail Did Not Display When Accessing the Summary View on the Approve Timesheets Screen

Defect 1388737

**Description:** When you tapped a charge detail of a timesheet on the Day tab in Summary view, the timesheet detail in Day view did not display. This issue is only encountered when you access the Summary view of a timesheet in the **Tasks » Approve Timesheets** screen.

**Customers Impacted:** This defect affects all Costpoint Mobile T&E users.

**Workaround Before Fix:** None.

## Error Encountered When Tapping the Pay Type Field after Adding Hours to Different Timesheet Days

Defect 1400216

**Description:** When you added hours to two different days, moved to another day, and tapped the Pay Type field of the charge while saving your changes, you encountered the "S\_UDT10\_SOURCE\_CD. This field has been disabled and cannot be modified" error.

**Customers Impacted:** This defect affects all Costpoint Mobile T&E users.

**Workaround Before Fix:** None.

## Truncated Period Text on Timesheet Search Screen

Defect 1405660

**Description:** The text in the Period field on the Timesheet Search screen got truncated.

**Customers Impacted:** This defect affects all Costpoint Mobile T&E users.

**Workaround Before Fix:** None.



## Costpoint Mobile T&E 2.0 Cumulative Update 03

This cumulative update applies to Costpoint Mobile T&E application 2.0.5 and Costpoint Mobile T&E Server 2.0.5.

**Released:** November 13, 2020

### New Features and Enhancements

#### Support for Token Storage on Android When Using SAML Service Providers

The Costpoint Mobile T&E application now supports token storage when you log into the application through any of supported SAML/third-party authentication providers on an Android device. When you log into Costpoint Mobile T&E using a SAML/third-party authentication provider, and then you log out, the PIN screen or the Biometric screen now displays on your next login instead of the SAML/3rd party authentication provider login page. To allow the application to store your third-party provider login credentials, you must install Costpoint Mobile T&E Server 2.0.5 or higher and make sure that the Reply URL on the server points to the new server location. Otherwise, the SAML/third-party authentication provider login page displays after the Costpoint Mobile T&E Login screen on your next login, requiring you to enter your SAML/third-party authentication login credentials.

### Software Issues Resolved

This section includes summaries of the software issues resolved included for this release.

#### No Validation Performed in UDT09 When Field Was Set up as Required

Defect 1377515

**Description:** The Costpoint Mobile T&E application did not perform validation in User Defined Tables (UDT) 09 when the field was set up as required while saving a new expense report.

**Customers Impacted:** This defect affects all Costpoint Mobile T&E users.

**Workaround Before Fix:** None.

#### System Error Encountered When Managing Attachments on the Approve Expense Reports Screen

Defect 1380885

**Description:** When you navigated to the **Tasks » Approve Expense Reports** screen as a resource manager (supervisor), and then uploaded, deleted, or marked an attachment as missing, the application encountered a system error.

**Customers Impacted:** This defect affects all Costpoint Mobile T&E users.

**Workaround Before Fix:** None.

## Application Name Displayed Without Spaces on the Biometric Login Screen

Defect 1380118

**Description:** The application name was displayed as "DeltekCostpointTE" instead of "Deltek Costpoint TE" on the Biometric Login screen on Android devices.

**Customers Impacted:** This defect affects all Costpoint Mobile T&E users on Android devices.

**Workaround Before Fix:** None.

## Application Error Encountered If the URL Contained Trailing Spaces

Defect 1379483

**Description:** The application encountered an error upon login if the Costpoint Mobile T&E URL contained trailing spaces.

**Customers Impacted:** This defect affects all Costpoint Mobile T&E users.

**Workaround Before Fix:** None.

## Pickers Not Displayed Correctly on Some iPhone 12 Devices

Defect 1378518

**Description:** Some pickers (for example, a date picker) were displayed and pushed to the bottom of the screen on specific iPhone 12 devices.

**Customers Impacted:** This defect affects Costpoint Mobile T&E users on iPhone 12, iPhone 12 Pro, and iPhone 12 Pro Max.

**Workaround Before Fix:** None.

## Favorites List Also Displayed UDT 02 Charges Even If Charge Type Was Set to UDT01

Defect 1378444

**Description:** When you added a charge to an expense report and set the **Charge Type** field to User Defined Tables (UDT) 01, the Favorites list also displayed UDT 02 favorite charges.

**Customers Impacted:** This defect affects all Costpoint Mobile T&E users.

**Workaround Before Fix:** None.

## Application Loaded Indefinitely When You Tapped Cancel After Entering the Server URL

Defect 1377588

**Description:** When you entered the Server URL and tapped **Cancel** instead of **Connect** on the Login screen, Costpoint Mobile T&E application loaded indefinitely.

**Customers Impacted:** This defect affects all Costpoint Mobile T&E users.

**Workaround Before Fix:** None.

## Favorites List Did Not Display UDT 01 Timesheet Charges

Defect 1377431

**Description:** When you added a charge to a timesheet, the Favorites list did not display User Defined Tables (UDT) 01 charges

**Customers Impacted:** This defect affects all Costpoint Mobile T&E users.

**Workaround Before Fix:** None.

## Unable to Open the Application Using Costpoint Mobile T&E Server version 1.0.x

Defect 1383789

**Description:** When you logged into the application using Costpoint Mobile T&E Server version 1.0.x, the application did not open correctly.

**Customers Impacted:** This defect affects all Costpoint Mobile T&E users using Costpoint Mobile T&E Server version 1.0.x.

**Workaround Before Fix:** None.

## SAML Service Provider Login Page Displayed When You Tapped Cancel on the Biometric Login Screen

Defect 1383423

**Description:** Tapping **Cancel** on the Biometric Login screen displayed the SAML/third-party authentication provider login page instead of the Costpoint Mobile T&E Login screen.

**Customers Impacted:** This defect affects all Costpoint Mobile T&E users.

**Workaround Before Fix:** None.

## Costpoint Mobile T&E 2.0 Cumulative Update 02

This cumulative update applies to Costpoint Mobile T&E application 2.0.4 and Costpoint Mobile T&E Server 2.0.4.

**Released:** October 26, 2020

Defect 1348306

**Description:** The **Personal** field value on the Expense Details screen dropped to zero when adding a meal expense type.

**Customers Impacted:** This defect affects all Costpoint Mobile T&E users.

**Workaround Before Fix:** None.

#### Unable to Edit Expense Incurred for Entertainment Expense Type

Defect 1352201

**Description:** The **Expense Incurred** field on the Expense Details screen was disabled when claiming an entertainment expense type.


