Details for all PIM versions from 19.1 to 24.1 are contained in the respective product documentation for those releases.

Note: You may still log support cases against unsupported software versions. However, please note that if you are running a version of PIM prior to 23.0, to resolve any issues that arise, we may require you to upgrade to the latest version.

Withdrawal of Third-Party Software Support

As of PIM 23.0, SQL Server 2012 & 2014 are no longer supported. If you are using these or prior versions of SQL Server, your site will be flagged as requiring a SQL upgrade when you submit a PIM upgrade request.

Reminder of Third-party Server Software Support

Please be aware that Microsoft have withdrawn support for the server versions 2008 & 2008R2 as of January 2020, and Windows server 2012R2 as of October 2023. If you are planning to upgrade to PIM 24.0 or above, and you are operating on one of these server versions, you will be required to upgrade your server. Please contact your Account Manager if you require a server migration.

Notice of Third-party Client Software Support

Please be aware that Microsoft have withdrawn support for the Windows 7 PC operating system as of January 2020 and Windows 8 / 8.1 as of January 2023. This means that PCs running this version will no longer receive security and framework updates. Owing to this, Deltek will limit any new client application development work to the currently supported versions of Windows 10 and 11 operating systems. We recommend that you review and update your client machines as a matter of urgency.

As of July 2022, SQL Server 2012 will be withdrawn from Microsoft support schedule, followed by SQL 2014 in July 2024. The next release of PIM will require you to upgrade SQL Server to a minimum of SQL 2016.

Mandatory SSRS Install to Receive PIM 20.0+ Upgrades

As part of our continuing product improvements, we are migrating our reporting in PIM into SSRS (SQL Server Reporting Services). From PIM 20.0 onwards, you will be required to make provisions for SQL Server Reporting Services in your PIM environment. Please contact your account manager for information

on how best to achieve this. Deltek can provide a guide that walks you through the process, which is recommended for clients with a capable IT department. Alternatively, Deltek offers a chargeable infrastructure service to configure this for you.

Server Software Requirements

To upgrade to this version, your web server environment must be on at least .NET Framework 4.8 and .NET 8. If these are not already installed, you may be asked to install this version ahead of your PIM installation or upgrade.

Client Hardware Requirements

Display Resolution

For an enhanced user experience, we recommend a display resolution of 1440 x 900 or higher. With evolving device technology standards, we have raised the minimum resolution requirement to improve information display across PIM's various pages. To ensure optimal viewing, please consider updating devices for users still operating PCs with lower resolutions.

Upgrade Actions for System Administrators

System administrators should consider the following actions after an upgrade:

Azure Single Sign-On

- If you have implemented PIM's Azure Single Sign-On in version 22.0 without upgrading to PIM 23.0, you need to add the following redirect URI to your existing Azure App registration, under the Authentication tab, for your PIM Single Sign-On entry:

https://{Your_PIM_Site_URL}/XWeb/Security/IdentityProviderCallback.ashx?provider=Microsoft&applicationType=Identity
```

- The Secret ID is now required to add an extra security layer to the Azure authentication model. If you previously implemented Azure Single Sign-On in PIM 22.0 without upgrading to PIM 23.0, you will need to revisit your Azure App registration to ensure a secret ID has been added under the Certificates & Secrets tab. If you don't have a secret ID registered, you will need to create one and then enter it into the corresponding field on the PIM Single Sign-On Configuration page in the Admin zone. This ensures the logon method works from PIM 23.0.

Email Flows (on-premises clients only)

- To futureproof your PIM system, consider your email provider construct and whether to implement against the new modernized mail flow features introduced in PIM 23.0.

Edge Hybrid Mode

Project Accounting users that use Internet Explorer (IE) for PA functions that still require IE should consider implementing Hybrid Edge IE Mode upon upgrade. This future-proofs access as PIM leverages modern browser features that may not work in full IE. Hybrid Edge IE Mode provides a seamless experience with modern browsers, and means users get IE on-demand when required, and the modern Chromium experience when IE is not required.

Post-Installation Information

This section provides information on additional components that you install to enable specific functionality in the PIM software. Some components are optional and depend on whether a user of a machine utilizes a particular feature.

Upgrading PIM Components

If you are upgrading from a previous version, you may already have the latest versions of some of the PIM user machine components. To determine if you need to upgrade a particular component on client PCs, compare your previous version of PIM to the version listed in the table below for any components that you currently have installed. If your previous version of PIM precedes the version mentioned for a particular component, you will need to upgrade it to the latest version. Your version of PIM is displayed on the bottom-right of the PIM Administration Zone screen.

To download the components for group policy packaging or direct user installs, navigate to:

Administration Zone > System Configuration > System Setup > Client Components

Outlook Add-in

You must install the latest version of PIM before you install the Outlook Add-in component. In addition, the Outlook Add-in requires .NET 4.8 to be installed on client machines.

Local File Management

Local File Management (LFM) requires .NET 8.0. If this is not already installed on a user's machine, the LFM installer will automatically install it. To install LFM, you are required to manually roll out the latest LFM client component to users' machines, either by Group Policy or by provisioning users with a link to the installer.

The LFM installer can be accessed on your upgraded PIM site here: Administration Zone > System Configuration > System Setup > Client Components.

Universal File Management

Universal File Management (UFM) requires .NET 8.0. If this is not already installed, the UFM installer will automatically install it. You must install the latest UFM component on all servers running UFM for Universal Document Control (UDC) to connect the remote file server with PIM.

The UFM installer can be accessed on your upgraded PIM site here: Administration Zone > System Configuration > System Setup > Client Components.

Attention: The UFM component typically undergoes updates with each major release of PIM. It is important to guarantee that you obtain the most recent version and install it on every server running UFM. This ensures compatibility with the upgraded version of PIM.

API Application

The API application now runs on .NET 8.0 on your PIM web server. This upgrade is included in the installation process and does not require any additional action.

Apryse Requirements

Apryse, which replaced the Rasterex Viewer in PIM 20.1 as the internal 2D document viewer for collaborating on drawings, office documents, and PDF files, requires Microsoft Visual C++ Redistributable 2015-2022 x64 to be installed on the server.

Mobile App Requirements

PIM 24.0 introduced new maintenance update versions of Android and iOS Timesheet & Expenses and PIM Mobile Working apps to bring them up to the latest operating system versions for both platforms.

As part of this maintenance update, the following minimum mobile operating system versions are required to update or install the latest mobile apps:

- Apple iOS 14 (this was iOS 12 in the previous release)
- Android 9.0 (this was Android 8.0 in the previous release)

If your device does not meet these requirements, you cannot update your mobile apps to the latest versions. The existing installed version will persist on your device, but it will not include the new features. In addition, backwards compatibility cannot be assured or supported if older app features are no longer viable with the newly upgraded PIM version. New Features: General

This section provides a summary of all new general features included in this release.

Teams Integration

The Teams Integration feature transforms document sharing and collaboration by seamlessly connecting PIM with Microsoft Teams. Designed to enhance productivity, the integration ensures organizations can work efficiently while maintaining document integrity, security, and version control.

Seamless Document Sharing

The integration simplifies how teams share and collaborate on documents, enabling PIM document series to be shared directly to Teams channels with ease. This functionality ensures discussions remain centered on the most up-to-date documents, while PIM retains the full revision history for accountability and traceability.

Key highlights include:

- **Streamlined Sharing Process:** Share individual or multiple PIM documents to Teams with a few clicks via the new 'Share to Teams' button on the PIM toolbar.
- **Collaboration in Teams:** Automatically create Teams conversations around shared documents, including direct links to the documents for seamless navigation between Teams and PIM.
- **Visibility Indicators:** Shared documents are marked with a Teams icon in the Teams column. Clicking the icon opens a detailed view showing the Teams conversations where the document was shared, along with the date and time of sharing, the user who shared it, and a link to open the corresponding conversation in Teams.

Administrative Controls and Secure Configuration

Secure Communication via Entra App Registration

The PIM + Teams integration connects to your Microsoft Teams instance through Entra App Registration. This enables users to log in to Teams within PIM and enables PIM to post to Teams on their behalf, while adhering to each user's Teams security profile. Users' OAuth tokens are securely encrypted in the database, ensuring the protection of access and user data.

The integration's administrative setup process is detailed in the relevant admin help pages and is further supported by the Deltek PIM Teams Integration Administration Guide, available in our Support Service portal.

PIM's Role-based Access for Teams Conversations

The following new entity functions cover the Teams feature set:

- **Teams.Admin:** Enables users to manage integration setup, user permissions, and oversight of shared documents.
- **Teams.ShareDocument:** Enables users to share documents to Teams channels.

Enhanced Collaboration Experience

The Teams Integration fosters efficient workflows and ensures alignment with the most up-to-date project information:

- **Support Across Platforms:** Integration is available in both Smart and Classic PIM, providing a consistent and flexible experience for all users.
- **Teams Conversation Integration:** When accessing the Summary Details (Smart DMS) or Document Details Panel (Classic DMS) for a document shared to Teams, a new Teams tab/section displays existing conversations linked to the document. This section includes options to create a new conversation for the document or reply to an existing conversation, facilitating seamless collaboration directly from PIM.
- **Integration Indicators:** The DMS results list now includes a Teams icon to identify shared documents. This feature allows you to locate shares quickly and engage in related Teams conversations directly from PIM.
- **Streamlined Management:** The 'Share Document to a Teams Conversation' screen centralizes Teams conversation creation, simplifying the sharing workflows and enabling you to collaborate directly from PIM.
- **Access Notifications:** Clear warnings are displayed if a Team, channel, or conversation has restricted access or has been deleted, preventing disruptions to the workflow.

Benefits

- **Improved Collaboration:** Centralizes document sharing and discussions within Teams, minimizing the need to switch between applications.
- **Enhanced Security:** Respects PIM and Teams permissions to safeguard sensitive information.
- **Efficiency Gains:** Simplifies workflows by reducing the steps required to share and collaborate on documents, allowing teams to focus on decision-making and execution.

These enhancements make the Teams Integration feature a powerful addition to PIM, supporting secure, efficient, and collaborative document management.

Enhanced Security with Role-Based Permissions for Advanced Searches

Control over Advanced Search queries has been enhanced with the introduction of role-based permissions, providing more granular access management. This update enables administrators to restrict who can create, edit, or delete shared or default search definitions, while ensuring that users can securely save and manage their own searches.

To support this, two new roles are introduced:

- **AdvancedSearch.Admin:** Grants full access to all saving options, including the ability to create and modify Standard searches visible to other users.
- **AdvancedSearch.ManageStandard:** Allows users to save searches as Standard, but limits access to elevated administrative functions such as editing or deleting system-wide searches.

Users without these roles can only save searches to their **My Saved Searches**. The "Save As" options dynamically adjust based on the user's role, ensuring that unauthorized users cannot modify or delete shared or default searches. By default, both roles are assigned to members of the **F01 role**, but administrators can grant the **ManageStandard** role to trusted users without giving full administrative privileges.

Updated Social Media Links on Landing Page

The Landing Page's Google Search dashboard now defaults to Deltek's social media links, replacing the previous "UnionSquare" links. You also have the option to customize these links to your organization's social media handles. This update allows users to quickly navigate to relevant social media pages directly from your Landing Page.

New Features: Document Management

This section provides a summary of all new document management features included in this release.

Enhanced User Experience with Auto-Search Toggle in the DLM Band

You can now disable auto-searching on the DLM band, providing a smoother user experience when working with large document projects. A new "Auto Search" toggle has been added to the DLM band's main ribbon, allowing you to control whether results are automatically updated when changes are made to groups or filters. This toggle state is saved as a user preference, offering you more control over your search process.

Direct Document Check-In from DMS Search Results Page

You can now check in a document directly from the DMS search results page in both Classic and Smart DMS modes, eliminating the need to navigate to the LFM page. The "Express Check-In" option is available under 'More options' for documents that have been checked out. This feature, available only when LFM is installed and configured, simplifies your workflow by reducing the number of steps needed to check-in a document.

Expanded Smart LFM Screen for Enhanced Record Viewing

The Smart LFM screen now expands to a larger size. This maximized view allows you to see more records at once, improving your workflow efficiency.

Enhanced Share Wizard for Large Files

To prevent issues when you share large files, the document share wizard now defaults to 'Download Link', bypassing the 'Max Basket for Email & Zip' limit set under Admin > DMS Configuration > Email Settings. This update also simplifies the sharing process by relocating certain fields to the initial step of the wizard.

New Renditions Column in Smart DMS Basket Mode

A Renditions column has been introduced to the Smart DMS Basket mode, offering functionality consistent with the existing Renditions column in Smart Drawing mode. This addition provides an at-a-glance view of document renditions for each document, and enables you to click on a rendition to open and view it directly. The column is fully customizable, enabling you to move, freeze, or unfreeze it to suit your workflow preferences, further enhancing workspace flexibility and usability.

Filter on Details for DMS and DLM Documents

A new filtering option in the Classic Search Builder enables you to refine search results in the Document Management System (DMS) and Document Lifecycle Management (DLM) by focusing exclusively on the content within the Details field.

New Features: Design Management

This section provides a summary of all new Design Management features included in this release.

AutoCAD Connector Compatibility with AutoCAD 2025

To ensure continued integration with Autodesk's 2025 range of products, which have transitioned to .NET 8 in their 2025 release, we have developed a separate AutoCAD 2025+ client component to support their new development framework. This new AutoCAD 2025+ add-in is required for AutoCAD versions 2025 and higher. User working with AutoCAD 2022-2024 will continue to use the previous version of the add-in, which is built against Autodesk's legacy framework.

Both the new and legacy framework client components are available on the Client Components page in the Admin Zone.

Revit/DLM Integrator Compatibility with Revit 2025

To ensure continued integration with Autodesk's 2025 range of products, which have transitioned to .NET 8 in their 2025 release, we have developed a separate Revit 2025+ client component to support their new development framework. This new Revit 2025+ add-in is required for Revit versions 2025 and higher. User working with Revit 2022-2024 will continue to use the previous version of the add-in, which is built against Autodesk's legacy framework.

Both the new and legacy framework client components are available on the Client Components page in the Admin Zone.

New Features: Project Accounting

This section provides a summary of all new Project Accounting features included in this release.

Porting Finance Lookup Editors to Modern Browsers

Various finance lookup editors have been updated to a modern browser platform, enabling administrators to configure essential items with improved efficiency and user experience. The various newly developed pages are added as menu items in the Project Accounting area of the Admin Zone, allowing the administrator to use the Admin Zone search to locate the required page / function more easily.

New Features: System Administration

This section provides a summary of all new system administration features included in this release.

Enhanced User Information in Manage API Access Page

The Manage API Access page now includes a new "Connected Users" tab under each OAuth ClientID. This tab provides detailed information about each PIM user logon, including their roles, token status, and connection timestamps. This additional layer of information allows PIM administrators to better monitor and manage API connections.

Enhanced UDC Configuration for System Administrators

PIM administrators now have access to a dedicated UDC Configuration page, accessed by navigating to **Admin Zone > Document Management > Configure UDC**. This feature enables administrators to define specific configuration values to optimize the performance of the UDC module, particularly for API synchronization of UDC documents.

For this release, the configuration page includes a setting for **Document Sync Batch Size**, allowing administrators to specify the maximum number of unmanaged documents PIM can receive from external sources in a single batch. This value can range between 100 and 10,000, providing greater control over synchronization efficiency and system performance.

New "Entered By" Filter in Action Management Tool

PIM administrators can now filter actions in the Action Management tool based on the user who entered them. This enables you to bulk change all actions created by a specific user, streamlining your workflow.

Enhanced Document Management

Bulk Publish Unmanaged Documents

PIM administrators can now bulk publish unmanaged documents into PIM from the Configure Unmanaged Source screen, streamlining the process of incorporating unmanaged documents into the document management system. The documents are processed and published as managed documents.

Note: Bulk publishing operates as a background process, meaning the PIM user's workstation does not need to remain online during the operation. However, the publishing of unmanaged documents is limited to those accessible by the UDC Prime Indexing user, not the user initiating the publishing action in PIM. Each folder to be published is processed in turn. Please contact Customer Care if you have any concerns about the speed of data importing.

Enhanced Pool Suggestions

The UDC Bulk Publisher offers a more comprehensive range of pool suggestions. All suggestions with the same confidence rating are displayed as possible matches, and previously used locations are included, even if they do not have initial matches. This enhancement simplifies your workflow, reducing the need to manually add pools for publishing.

Access-Aware Publishing

The UDC Bulk Publisher dynamically checks your write access to document pools before publishing. If a pool is suggested but you lack the necessary permissions to publish to it, the system clearly indicates this with a message. To prevent publishing failures, the **Publish Selected** button remains disabled until all selected rows are assigned to pools where you have the appropriate permissions.

Updates to Entity Function Roles

As part of this new feature, the entity function roles concerning Universal Document Control have been updated, and the following roles now exist:

- **UDC.Admin:** Specific role for UDC administrators and replaces previous DMS.Admin user role.
- **UDC.Map:** Enables users to map new project document sources.
- **UDC.BulkPublish:** Enable users to bulk publish unmanaged documents from the
- **UDC.Publish:** Enables users to publish unmanaged documents from the Configured Unmanaged Source screen.

Bulk Move DMS Documents to Recycle Pool

The Bulk Move Documents feature has been reinstated. This enables PIM administrators to bulk move DMS documents to the recycle pool, simplifying the process of rectifying users' mistakes. The feature is only available in SMART DMS and can be accessed by clicking the **Bulk Recycle** button in the Smart Information Zone and Documents bandset. This feature is only visible to members of the Dms.BulkRecycle entity function role.

Preserve Published User and Date when Moving Documents

As a PIM administrator, you can now correct the location of incorrectly published documents without affecting the publish user or date. This feature allows you to move hundreds of documents from one pool to another while preserving the published user and date, enabling efficient housekeeping of the DMS. The new toggle – **Preserve Published User and Date** – is available when you select to move documents in the DMS and is only visible to users with the Dms.Admin entity function role, ensuring secure and controlled use of this feature.

Software Issues Resolved

Descriptions of Software Issues

This section includes all fixes in this release. Some of the descriptions might contain extra information, including ways to work around the defects. This additional information has been included in case you instituted some of the workarounds and can now stop using them by requesting an upgrade, or you simply want more background information about the defect repairs.

General

Defect 2098321

When you worked on a project in PIM and excluded a certain number scheme, the excluded scheme still appeared in the Available Schemes section under the DLM tab in the Administration section.

Defect 2145171

When you tried to upload Excel documents into the DMS system, and after checking out existing Excel files, when you attempted to check them in, the following error displayed: "Error 4653807: A problem occurred when processing a request to the server."

Defect 2145174

When you published an email using the Deltek PIM Outlook add-in, in rare cases, an error displayed.

Defect 2145175

When you completed, closed, or modified an action, and then refreshed the My Actions dashpart in your Personal Zone, the dashpart did not display the updates.

Defect 2145177

When you published files through LFM or via the File Upload feature, the status for documents was not displayed in the Document Status column when viewed through Smart View Drawing Mode. Instead, you had to view the summary details for a document to view the status.

Defect 2157795

When you edited a DLM placeholder and updated the originating organization via edit properties, the organization previously listed in the document attributes was removed.

Defect 2160432

When you clicked 'Add Files from Folder' in the Smart Superseder tab of a project without Local File Management (LFM) installed, you received the following error: "Byte array for GUID must be exactly 16 bytes long."

Defect 2162724

When you resized the Document Details Panel in DMS, the panel could be enlarged, but then prevented you from reducing its size. This resulted in the resize function remaining active even without holding down the left mouse button. This issue was observed in Chrome, Edge, and Edge in hybrid mode, but not in Edge in IE mode.

Defect 2166386

When you attempted to set up 2FA as a Teamwork user after migrating to the cloud, the generated 2FA code provided in the email did not work, and you received the following error: "That code was invalid, please try again." This issue occurred for both existing and new Teamwork users.

Defect 2169368

When you clicked 'Finish and Process Now' when issuing DLM documents, the issue number was missing from the email subject. This issue affected PIM 24 only.

Defect 2172904

When you attempted to export over 1,000 documents using the Document Export/Removal tool, the 'Yes, Proceed' button became unresponsive, and you could not complete the removal or export task.

Defect 2179168

When you published files and assigned actions, in some cases, the actions were not displayed on the Actions tab when you view the document properties of the published documents.

Defect 2179302

When you chose to issue documents via Email in PIM 24, the email did not contain document links.

Defect 2179931

When you configured and enabled Azure SMTP Client as the new email provider and set the smart host to smpt.office365.com, PIM continued to use the local SMTP config/server for outbound emails. This meant that when you tried to send an email through the DMS or assign an action, an error appeared on the latest queue job, and recipients did not receive the email.

Defect 2181813

When you performed an unfiltered DLM Placeholder search on a large-scale project with thousands of placeholders, and applied the Originating Organization grouping, the following error displayed: "An error occurred".

Defect 2182824

When you sent a DLM issue using the Finish and Process option, the file attachments were missing in the sent email.

Defect 2189713

When you issued DLM documents, and you included apostrophes in the email body, they were converted to â€™ in the received emails.

Defect 2195680

When you renamed a user role with an apostrophe or any unescaped character in its name, it caused an unexpected identifier console error, and the User Roles page was blank after a refresh.

Defect 2203832

When you published files to the incoming documents pool using LFM, and published those files using the Smart Superseder, in some cases, the document date did not display in the respective date column within the DMS.

Defect 2209229

When you attempted to export an Excel file from the DMS for a project or enquiry that had a comma in its name, the file exported with an invalid .file file extension, and you could not open it in Excel.

Defect 2212947

When you set up a large number of milestones for a project and navigated to the Milestones tab, a scrollbar did not appear to allow viewing of all milestones. This issue occurred even when the browser was resized to be shorter than the list. As a result, you were unable to scroll down to the bottom of the page.

Defect 2221603

When you used the Smart Superseder to add files from a folder, the search bar on the Local File Management (Smart Superseder Mode) window did not allow you to filter the list of files in the local directory.

Defect 2265105

When you attempted to share project documents, the contacts for the project did not auto-populate on the Send Email To screen as expected. This issue occurred in PIM 24.0.2.

Defect 2211776

When a user updated their DMS search preferences, it could overwrite other users' DMS search preferences.

Document Management

Defect: 2120434

When you clicked the **View Document** icon for an older version of an image file, the latest/current version displayed instead of the intended previous version. This issue was observed when the View Method was set to **Image** for image file types (e.g., JPEG, JPG, PNG) under **Admin > Document Management > DMS File Extensions**.

Defect: 2172132

When you started the LFM app with an incorrect base URL configured or other installation errors, the following misleading error message displayed: "Your Deltak LFM installation is out of date."

Defect: 2195979

When you tried to load the **Manage Sets** page via the Admin Zone or select **Available Sets** within a project, a timeout error could occur if thousands of DLM sets were configured and used in DLM schemes.

Defect: 2206919

When you attempted to publish documents via the **Smart Superseder**, changing the document title caused its status to change to **New**. As a result, the **Publish Selected** button was greyed out, and the tooltip displayed: "It is not possible to Supersede a Snapshot Publish document."

Defect: 2212535

When you added an originating organization to a placeholder created from Revit, the following error displayed: "Expression must evaluate to a node-set." This error prevented the addition of the originating organization to the placeholder.

Defect: 2211776

When a user updated their DMS search preferences, it could overwrite other users' DMS search preferences.

Universal Document Control

Defect: 2112789

When you renamed a network folder in a PIM project, the files remained under the old folder name in the unmanaged documents pool, even though the folder had been renamed. After refreshing the DMS page, both the old and new folder names displayed. The expected behavior was for the files to move to the folder with the new name.

Defect 2183347

When you added a file to a mapped network folder and synced to PIM, unmanaged files were not extracted in some cases, and an error about invalid characters appeared in the system logs.

Workflow

Defect: 2153633

When you viewed and replied to a contract management item, any text changes made in the Reply text field after two minutes from opening the window were removed upon resizing or moving the web browser window.

Defect: 2199141

When you removed a contract management item type via the workflow admin settings, it was still possible to create new contract management items of that type from a project.

Defect: 2213042

When you clicked email links for snag/punch list items or DLM approval tickets assigned to you as a Teamwork user, in some cases, the following error message displayed: "You do not currently have permission to access this area".

Defect: 2159166

When you created new contract management items with Disable Replies selected in the contract management admin settings, you were unable to add recipients for email sending. This issue occurred regardless of whether Recipients Not Required was selected or not.

Mobile Working

Defect: 1550183

When you viewed a custom form on an iPad and clicked on a question longer than 90 characters, the question was cut short in the top bar of the answers page. On an iPhone, the question disappeared completely after being clicked. This issue only occurred with iOS devices (versions 15.0 and 15.0.2) and did not affect Android devices.

Defect: 1588680

When you entered data into mandatory fields on a custom form via the mobile app, the labels for these fields inconsistently changed color. This behavior varied between iOS and Android devices and depended on the type of control in use.

Defect: 1626474

When you logged into the PIM Mobile Working iOS app for the first time and navigated to PIM Live Browsing, an unexpected login screen appeared. This occurred when you selected the "Exclude Emails" checkbox to search for documents, clicked on a document, and then clicked **View Document**. Instead of the document loading immediately, another login screen was displayed.

Defect: 2168268

When you attempted to submit a subform without filling in all required fields using the PIM Mobile Working app for iOS, the app crashed.

Defect: 2199200

When you attempted to take and submit photos via **Tools > Take Photo** on the PIM Mobile Working app for Android, despite completing all mandatory fields, the following error displayed: "Please complete all mandatory fields before submitting."

Defect: 2160458

When you renamed an existing workpackage on a project or enquiry's Workpackage band, the new name did not reflect in the Workpackage dropdown under the Snagging/Punch Lists band. As a result, snag/punch list items with the renamed workpackages could not be filtered, slowing down productivity when a large quantity of snag/punch list items existed for the project/enquiry.

Defect: 2220255

When you submitted a snag/punch list item for review, the notification email for outstanding snag/punch list items incorrectly CC'd only the Admin User, regardless of the assigned snag/punch list item reviewers for the project.

Defect: 2220962

When you issued snags/punch lists from a project entity and checked the summary of the corresponding snag/punch list email in the document management system (DMS), the project value incorrectly displayed as "???" under Attributes.

Defect: 2245755

When you received an email notification from a mobile custom form with an email distribution list enabled, clicking the link to download the documents resulted in the following error message: "You do not currently have permission to access this area."

Project Accounting

Defect: 2145165

When you linked different sources of entitlement to a single absence category in the Categories Management section under **Admin > Absence**, issues occurred if the entitlement sources had different providers, such as Hourly and Daily providers.

- If the contact entitlement was set to Daily, the absence booking changed to hours instead of days when edited.
- If the contact used an hourly entitlement and a common category name like "Holiday," it created a duplicate in the Category dropdown. This also resulted in incorrect hours being deducted on the display, not aligning with the hours set in WWS.

Defect: 2219321

When you attempted to sync the Timesheet Mobile App with the PIM site on an Android phone, an "Unable to Sync" error displayed if the workflow module was disabled or stopped.

Defect: 2246851

When you edited and then moved a resource plan that had at least six contacts assigned, a timeout could occur upon saving if the contacts had allocations or absences linked to other projects.

Defect: 2260877

When you edited the expense currency via the Manage Expenses function, the exchange rate was not updated upon submitting the timesheet. This issue occurred when the **Use Current Exchange Rate When Posting Expenses** option in the Project Accounting configuration was unticked, and the project was linked to an organization using a different currency.

Search Definitions Moved to Xweb

All advanced “search definitions” in PIM have been relocated to the modern Xweb section of the site, specifically under the “search” folder. Customized versions of standard searches are expected to remain operational post-upgrade.

HTTP Security Headers

PIM 24.0 extends the following HTTP Security Headers as part of your PIM website to assist with your security posture:

- Permissions-Policy/Feature-Policy Header
- Referrer-Policy Header
- Strict-Transport-Security (HSTS) Header
- X-Content-Type-Options Header
- X-Frame-Options Handling
- Content-Security-Policy Header

In the past few releases of PIM, we have been preparing heritage clients for final transition to full HTTPS operation of their site. The new HSTS security header will finally force HTTPS for any external facing web requests, meaning there is a slight risk of aged custom integrations still requiring HTTP ceasing to function. We have managed forcing HTTPS over the last few releases by virtue of your site config that can be changed easily on upgrade. However, this latest change cements the move to HTTPS.

Appendix C: Known Issues in Previous Releases

This section provides information about known issues in previous releases.

Mailbox Alias Email Setting Only Applies to Certain Outbound Email Types

The new Mailbox Alias Email configuration setting will only apply to certain outbound emails. We are aiming to resolve this as part of the modernization of PIM's mail flows across the product. This is fixed from version 24.1.

Previous Mandatory Entity Classifications No Longer Mandatory after Upgrading

After you upgraded, you should ensure that all previous mandatory classifications are still mandatory. If you found that some classifications were no longer mandatory, you were required to re-enable their mandatory status in the Entity Class Classifications tab in the Manage Entity Lookups page. Within this page, you can also specify which entity classes allow users to select multiple classifications.

For more information on updating entity classifications, refer to the Manage Entity Dropdowns section in the 19.0.2 release notes.

Share by Download Feature in Workflow Fails if the Resulting Zipped File Is Over 4GB

When you used the Share by Download feature in Workflow to share a batch of documents from the document management system, if the zipped file that is created was larger than 4GB, the process failed. If this occurred, you were required to split the documents into multiple batches. Alternatively, the preferred method for distributing large files was the DCS Distribute by Download feature.

Missing Contact Roles in DLM Approval Route Templates Organization Roles

When you edited a stage in the Approval Route Templates Organization Roles screen, information was missing in the details listview for contact roles, even when you previously set a value. Additionally, if you clicked the Add button in the listview, it duplicated any previously saved items.

Create Routes and Manage Routes Icons Duplicated in Manage Project Approval Settings Screen

When you accessed the Manage Project Approval Settings page through the Manage Document Approvals screen, the Create Routes and Manage Routes icons were duplicated in some cases.

Slow Performance When You Add Rows and Edit Row Settings in the Manage Approval Route Groups Page

When you added a row for a group in a stage in the Approval Route Groups page, or edited the settings for a row, you might have noticed a delay in performing the action. In some cases, this delay could cause a page refresh, which resulted in you losing any unsaved data.

Documents Missing in the Offline Documents Band in Some Projects

In some projects, offline mobile documents may have been missing in the Offline Documents band. Note that this did not affect your ability to offline a document or make it available for location markup.

Slow Performance Loading for Some Look-Up Editors

For the Manage Lookups pages that contained many tabs, or display tabs with complex data structures, the pages could take a few seconds to load.

Security Grids

In PIM 20.1, the legacy security grids have been separated into individual pages for each type, rather than a single page for all types. Although the new menu item security grid allowed you to grant a user role with access to individual grid types, if a user role had been granted access to one security grid type, they had access to all security grids. This rule will persist, as it is thought that a user role with sufficient rights to configure one security type should be responsible to configure all security types. By default, only user roles that had access to the single legacy security grid are granted access to all new security grid pages.

Firefox Displays Misaligned Text in Search Boxes

When you accessed PIM via Mozilla Firefox, the text within the search boxes was not correctly aligned.

Issues with Workflow and Document Removal

There were two known issues with the Document Removal feature and the Workflow module:

- When you attempted to send a tender out that included a document that was removed, the tender failed to get sent.
- When you removed a document after it had been issued as part of a tender or used in DLM approvals, a non-intuitive error message displayed when you attempted to download the removed document.
