West Virginia 2024 SUTA Wage Limit

ComputerEase now uses the updated 2024 SUTA wage limit for West Virginia.

To view the SUTA wage limit, click **Payroll System » Maintenance Program » Tax Rate Maintenance » State Tax Table Maintenance**. On the State Tax Table Maintenance dialog box, enter WV. And then, on the 2024 WV Tax Settings window, click the SUTA tab.

Colorado Allows 8 Character Employer Account ID Number

On the Create Magnetic Media dialog box (**Payroll System » Reports » Tax Reporting » State Unemployment Report » Create Magnetic Media**), a warning message now displays when an employer account number does not meet the 8 or 9 character requirement for Colorado.

ComputerEase Sometimes Crashed when Opening Invoice Attachments

Defect 2069493: When you were opening the attachments of an invoice on the All Groups window (**Accounts Payable » Invoice Approval » All Grops**), ComputerEase sometimes crashed.

Oregon SUTA Report could Contain Incorrect Paid Leave Participation Status

Defect 2075240: When you printed the Oregon SUTA Report (**Payroll System » Reports » Tax Reporting » State Unemployment Report » Print Report**) for employees with differing values by quarter, the paid leave participation status of employees was incorrect.

Work in Progress Center Report Error with a T&M Job

Defect 2076278: When you ran a Work in Progress Center report with a T&M job specified on the Work in Progress Center window (**Management Centers » Work in Progress Center**), an error dialog box was displayed instead of having no detail to report.

Clicking Login Multiples Time Caused ComputerEase to be Unresponsive

Defect 2076369: When you clicked **Login** multiples times on the Welcome to ComputerEase window, ComputerEase became unresponsive.

Missing Graph Tooltip in Receivables Center

Defect 2077738: When you set **Notes** and **Attachments** to **No** on the Receivables Center dialog box (**Accounts Receivable » Receivables Center**) and displayed the Receivables Center, the tooltip when you hovered over a graph was missing.

Washington Family Leave Report Missing CARES Column

Defect 2078178: When you printed the WA Family Leave Report on the WA Paid Family and Medical Leave dialog box (**Payroll System » Reports » Tax Reporting » State Paid Family Leave Reports » WA Family Leave Report**), only the PFML taxable amount column was displayed while the CARES taxable amount column was not.

Incorrect Location and Size of Rectangles in Printed Custom Reports

Defect 2078559: When you printed a custom report that draw rectangles using the PDF-XChange printer, the rectangles in the report had the wrong location and size.

Clicking Print a Subcontract Selected Enter a Change Order

Defect 2080646: When you clicked **Print a Subcontract** in the Utilities section on the Subcontract Center window (**Subcontract » Subcontract Reports » Subcontract Center**), the Enter a New Change Order dialog box was displayed instead.

QTool Report Unable to Display Text in Grid Cells

Defect 2081897: When you ran a QTool report, QTool was unable to display the text in the grid cells and could crash after refreshing the report multiple times.

No Error Message Displayed for Work Ticket Number When Exporting Work Orders

Defect 2084762: When you exported multiple work tickets from FieldEase and a work ticket was unable to be assigned, no error dialog box was displayed and ComputerEase became unresponsive.

State Tax Override Error in Payroll Register and Checks

Defect 2087059: When you printed the payroll register and checks, the state tax was changed to zero and the actual amount differed from the stub by the original state tax amount. This occurred under the following conditions:

- An employee had time resulting in state income tax withholding for a state where paid leave was disabled
- A state tax override amount was entered for the paid leave and the state tax override amount was blank

Add Multiple Approval Teams in Create/Edit a Job

A new window is now added to simplify viewing, adding, or editing Approval Teams for multiple jobs. On the Create/Edit a Job dialog box (**Job Costing System » Job Maintenance » Create/Edit a Job**), you can now select **File » Edit Approval Teams**. This displays the Add Jobs dialog box for the Edit Approval Teams window.

To add and filter multiple jobs, you can use the following fields on the Add Jobs dialog box:

- **Customer**
- **Job Class**
- **Job Status**
- **From Job**
- **To Job**

To select multiple jobs for modification, you can use the following buttons on the Edit Approval Teams window:

- **Add Jobs:** Provides filter options to call the jobs you wish to view, edit, or modify
- **Select All:** After jobs were called through **Add Jobs**, **Select All** selects the checkboxes for the jobs where your Approval Team changes will apply.
- **Select None:** Clears all checkboxes for selected jobs.
- **Selection Approval Team:** Selects the Approval Team to be applied to the selected jobs.
- **Save:** Saves changes to apply your changes.

Note: Pending time entries are redirected to the appropriate Approval Team.

Payroll Service Users' Ability to Add Missing SUTA State for an Employee

On the Taxes tab of the Employee *Name* window (**Payroll System » Maintenance Programs » Employee Maintenance**), Payroll Services users can now specify the missing SUTA state for an employee in the **State** field on the *Year SUTA* section.

Note: A missing SUTA state occurs when a user had created an employee, but did not have permission to access the Taxes tab.

Save Tooltip for Save Icon on Edit Workflow Window

On the Edit Workflow window, a "Save" tooltip now displays when you hover your cursor over the **Save** icon.

Primary Work Order and Item Work Order Information in Purchase Order Import File

When you add or edit a layout on the Purchase Orders Import Layout - *Company Name* window (**Purchasing & Inventory » Work on Purchase Orders » Import Purchase Orders**), you can now specify work orders in the import.

The **poworkorder** field imports to the **Primary Work Order** field on the Main tab of the Purchase Order Entry/Edit windows, and the **itemworkorder** field imports to the **Work Order** field on the Purchase Order Items tab in Item Distribution.

Payroll Service Users Now Require ID, State, and FIPS Information for Employees with Child Support Activities

As a payroll service user running a Payroll Register, an error now displays when there are employees with non-zero child support activities in the payroll with a blank **ID / State / FIPS** field on the Deductions/Fringes tab of the Employee *Name* window (**Payroll System » Maintenance Programs » Employee Maintenance**). Entering the missing data will fix the error and allow the user to proceed with processing payroll.

Approval Team Information in QTool Job Master Report

When you create a QTool Job Master Report, you can now select **Approval Team** as a column option to specify approval team information in the report.

Negative Total Expenses Amount for Non-Reimbursable Expenses and Reimbursable Expenses

On the Work on Non-Reimbursable Expenses window (**Accounts Payable » Expense Management » Work on Non-Reimbursable Expenses**), you can now post expenses with a negative total expenses amount.

Alabama State Withholding Report for Taxable Wages

Defect 2064886: When you selected a specific type checkbox for an equipment filter, such as **Revenue**, **Cost to Own**, or **Cost to Operate**, and performed a sync, all types of codes were synced instead.

Unable to Apply Permission Changes to Users as a PW MAINT User

Defect 2065005: When logged in as a PW MAINT user, you were unable to edit and apply permission changes to multiple users.

Incorrect Nevada MBT Rate for 2024

Defect 2066178: The configured 2024 MBT rate for Nevada was incorrect.

Incorrect FIPS Code Positions for Record A of North Carolina SUTA File Export

Defect 2066727: When you exported a North Carolina SUTA file, the Record A code positions containing the FIPS codes were incorrect.

Running a User Report Sometimes Caused a Crash

Alabama Updates

For the tax year January 1, 2024, Alabama pay received by full-time hourly employees for hours worked over 40 in any given week are exempt from Alabama State Income Tax. For specific details on this ruling please refer to the State of Alabama publications. To accommodate this regulation we have provided the following:

- The **Multi State Calculation for Residents** field and **Multi State Calculation for Non-Residents** field are now removed from the 2024 AL Tax Settings window as they are hard coded (**Payroll System » Maintenance Programs » Tax Rate Maintenance » State Tax Table Maintenance**).
- A submenu has been created under **Payroll System » Reports » Tax Reporting » State Taxes Withheld » Alabama Overtime Exemption**. This new menu contains two new reports to assist you in reviewing required information to be reported for 2023 and recurring (Monthly/Quarterly) in 2024.
- **Payroll System » Reports » Tax Reporting » State Taxes Withheld » Alabama Overtime Exemption » “Alabama 2023 Overtime Report”** provides the overtime values requested by the state regarding 2023 paid overtime wages.
- When generating the Payroll Register, the system will now automatically assess the Alabama subject hours based on the work date and calculate the recommended hours and wages for exemption. Note that Alabama does not consider Sick, Vacation, and Holiday hours when determining the exempt hours worked over 40. Neither does it allow exemption for Salaried employees. If you are paying Alabama Subject Wages, it is recommended you enter the time through Labor Distribution with a Date as Alabama determines exemption for hours over 40 worked based on 7-day period. For those running semi-monthly payrolls with partial weeks, you may need to manually adjust the exemptions through the new Alabama Tax Over-ride function.
- Should you wish to manually override the hours and wages to be treated as Alabama Exempt, within **Payroll System » Enter Labor Distribution by Employee**, when performing Entry » Tax Override, State Tax there is now an option within the state of AL for Exempt Hours and Exempt Wages.
- If there are Alabama subject wages in a pay-run, a new report “Alabama OT Exemption Payroll Register Report” outlining the systems automatic exemption information will print after the Payroll Register.
- **Payroll System » Reports » Tax Reporting » State Taxes Withheld » “Alabama Monthly/Quarterly Exemption Report”** provide (in detail or summary) the hours, wages, and count of employees with exemption.
- For users who are manually loading earning balances through **Payroll System » Maintenance Programs » Month to Date Maintenance**, when loading earnings for Alabama, Exempt OT Hours and Exempt OT Wages can now be entered.

Rhode Island Temporary Disability Insurance (TDI) Wage Base
