**Workaround Before Fix:** When the error displays, click **OK** and then continue entering the record.

**Description:** The application did not calculate additional Medicare withholding amount when you entered a manual record for an employee that had existing checks totalling 200,000 (Year-to-date (YTD) Medicare Taxable Amount). This issue occurred if the manual record had the same check date as the existing check that placed the employee's YTD Medicare taxable wages on the 200,000 threshold amount.

**Customers Impacted:** This defect affects Costpoint 7.1.1 Payroll users.

**Workaround Before Fix:** Change the check date to the next day and recalculate. After recalculating, change the check date back to the original date.
