Deltek recommends that you always install the latest version of the Workspace Client in order to ensure compatibility with the most recent CUs.

Notification Recalculation Failure

Deltek Tracking: 1853697

When a notification type was configured with Duplicate Handling set to **Keep Last** (rather than **Allow Duplicates**), notification recalculation as a whole previously failed. This error is corrected.

Missing Custom Name Space in the Custom Popup Container

Deltek Tracking: 1831127

In the Containers Web Service specification of a custom popup container, the custom name space was previously missing from the value field's enumType property. This error is corrected.

Important Notes for CU 14

Software Issues Resolved – Application (APU)

Print Layouts Were Deleted Without Validation from Users

Deltek Tracking: 1737470

For convenience, Maconomy remembers the selected Print Layout in the Reminder and Invoice workspaces. If the setup of these layouts is altered, Maconomy would forget the selected layout and require the user to reselect. Issues from before this fix can now be corrected by altering one of the Print

Layouts for "Approve Interest Selection" or "Approve Reminders". That is, users can change one External Layout Name and then change it back.

Software Issues Resolved – Tooling

BPM Statutory Reports: Issues with Linux Folder Structure

Deltek Tracking: 1818771

Maconomy systems (2.5.2 and later) installed in Linux previously gave a "Could not find a file with name:" error when trying to access the UK Tax Submissions and Statutory Reporting workspaces. This is because folder names in Linux are case-sensitive.

The following workaround can be applied to fix the issue:

- In the Maconomy installation folder, navigate to MaconomyDir\WorkspaceDefinitions\, then rename BPM_Common, BPM_StatutoryRetrieval, and UK_TaxSubmission folders to all lowercase.
- In the Maconomy installation folder, navigate to MaconomyDir\DialogLayouts\, then change the casing of each folder to all lowercase.

Software Issues Resolved – Application (APU)

Adjustment Error

Deltek Tracking: 1534619

In Evaluation of Work in Progress, when you approved an adjustment on a job that has no budget lines and no job entries, no adjustment took place. This error is corrected.

Software Issues Resolved – Technology (TPU)

Task Generator Surveillance Task Block and Timeout

Deltek Tracking: 1673393

Previously, a background task rule execution that was taking a long time to finish prevented the task generator surveillance task from running, which would eventually timeout. This error is corrected.

Moving Tables Rows Causes Server Crash

Deltek Tracking: 1637898

In the Spec. of Output Data Records dialog, MaconomyServer previously crashed when moving lines up and down or in and out. Sometimes the move was not performed at all. This error is corrected.

Line Feeds in Configured Fields Error

Deltek Tracking: 1639056

Previously, having line feeds in configured fields resulted in an error when using UpdateLog. This error is corrected.

Additional Formats for Default Filetypes

Deltek Tracking: 1670316

The following are introduced as new default accepted file types for Security FileCheck:

- 7-zip archive data
- ISO-8859 text
- Rich Text Format data

Security FileCheck Cannot Handle Non-ASCII Characters in Filename

Deltek Tracking: 1670320

If Security FileCheck was enabled and you previously tried to upload a file with fx. Danish or Swedish characters in the filename, the FileCheck failed because the File command could not open the file. This error is corrected.

Software Issues Resolved – Application (APU)

Error When Using Create Payment Selection Action

Deltek Tracking: 1579969

Previously, Maconomy would incorrectly change the values in the **Remainder**, **Currency** and **Payment**, **Currency** fields when you repeatedly use the **Create Payment Selection** action. This error is corrected.

Software Issues Resolved – Technology (TPU)

Stack Trace Exception Logging Error

Deltek Tracking: 1604594

When performing notification calculations, the code previously logged exceptions including stack traces in cases where it should not have. This led to spamming of the log file in cases where the system was not optimally configured. This error is corrected.

Deadlock Occurs When Deleting Old Tasks

Deltek Tracking: 1605449

The background task schedule rule "CleanComplBgrTasks" creates a background task that cleans up old and completed background tasks each day. When this clean-up task was previously running, a deadlock occurred. This led to tasks not being cleaned up and scheduled rules not running. This error is corrected.

Background Tasks Stay in Committed State

Deltek Tracking: 1606605

In rare cases, a background task could previously end up in a state of Committed indefinitely. This meant that other tasks depending on that task would never be executed. Additionally, if this happened to the system task, no schedule rules would run. This error is corrected.

Default Max Age in Cache Control Headers Lowered from 24 to 8 Hours

Deltek Tracking: 1605383

The default max-age supplied in Cache-Control response headers by the Maconomy Configurations Web Service is lowered from 24 to 8 hours. This change is made to make the process of deploying new web configurations easier.

Incorrect Value in First Year-Period of Quarter

Deltek Tracking: 1413862

When there were more than one Company No. for a Tax Reporting Unit in the Submission History tab of the UK Tax Submissions Report, a #MULTIVALUE previously displayed. This error is corrected such that it shows the list of companies per Tax Reporting Unit.

Software Issues Resolved – Technology (TPU)

AC-Views Performance Issues

Deltek Tracking: 1552368

AC-Views added with previous CUs resulted in Oracle performance issues. This error is corrected.

Table Line Update Fails with REST API Internal Server Error

Deltek Tracking: 1592957

Previously, updating a field in a table line failed with an internal error. Users would then have to refresh and try again. For REST integrations, this resulted in the REST API returning 500 "Internal Server

Error". In the maconomy.log, "Illegal state: No record value available in container executor" was noted. This error is corrected.

Incorrect Document Sent During Email Generation

Deltek Tracking: 1592957

There was previously a bug in the generic container action emailOnAction. When an error occurred during email generation, the document sent was not cleared from the internal state and was added to the next e-mail generated by the same thread. This error is corrected.

Security Policy Error for File Import and Export

Deltek Tracking: 1596572

Previously, an error was displayed when using the **Export to Excel** action in a Sales Order. The error noted that the file was rejected by installed security policies. This error is corrected.

HTML File Uploaded When Not on Allow List

Deltek Tracking: 1592548

Previously, if the allowlist of the file checker contained the line: ASCII text, then it was possible to upload an HTML file because the output of the file command contained this text. This error is corrected. The file checker now ensures that the allow list checks that it starts with text instead.

Software Issues Resolved – Web

Error When Using Old Schema.json After a CU Upgrade

Deltek Tracking: 1572048

Browsers: Chrome, Safari, and Firefox

After installing a cumulative update (CU) on a three-point Maconomy release, users occasionally encountered an "Invalid Application Configuration" error. This occurred whenever the CU introduced an updated schema.json file. This is now corrected.

Performance Issues When Running Data for Finance VAT Entries

Deltek Tracking: 1325961

Previously, users experienced a database timeout issue with the GoBD report when running large volumes of data for Finance VAT entries. This error is corrected. A query optimization now improves the runtime of Finance VAT entries.

Timeout Error When Running Large Data for Job Entries

Deltek Tracking: 1437320

Previously, users experienced a database timeout issue with the GoBD report when running large volumes of data for job entries. This error is corrected.

Timeout Error When Running Large Data for Job Master

Deltek Tracking: 1437321

Previously, users experienced a database timeout issue with the GoBD report when running large volumes of data for Job Master. This error is corrected.

- Gov-Client-User-Agent – This requires **url.mtdsysmanufacturer** and **url.mtdsysmodel** to be set in the server.ini file. **See Appendix C: Setup by Country » United Kingdom for more information.**
- Gov-Vendor-Product-Name

Hardcoded Boxes in the UK MTD Tax Submission Report

Deltek Tracking: 1386086, 1416241

Effective January 1, 2021, the new HMRC MTD BREXIT rules dictate that Boxes 2, 8, and 9 in the form will no longer be used. These boxes are an EU-specific requirement and no longer apply to the UK as of the beginning of this year.

The boxes are now hardcoded with a zero value.

Note: These fields still need to be filled in for Northern Ireland Protocols which, while part of the UK, is still an EU member. See **Appendix C: Setup by Country » United Kingdom » Making Tax Digital (MTD) Tax Submission Report » Set Up Country Code Fields** for more information.

Period Change Keys

Deltek Tracking: 1416234

Period change keys are updated from numeric format (NNNN) to alphanumeric format (NNAN) for quarterly filing, while NNAA for monthly/annual filing. The **Date Submitted** field is now included in the table to check if the entry has been submitted to HMRC.

NSAFT

Ability to use Option List - Remarks 2 as Tax Code for NSAFT

Deltek Tracking: 1434382

NSAFT now has the capability to override the tax code using the remarks 2 field from the same option list for mapping standard tax codew. This feature will override <TaxCode> under <TaxTable> and <TaxInformation>. Character limit of 9 is still enforced for the values from the remarks 2 field. If the Tax Code is neither in the option list nor mapped with a remarks 2 field it will show the original tax code from the Tax Code dialog in Maconomy.

Software Issues Resolved – BPM

UK MTD

Negative Figures Unsupported on Box 5

Deltek Tracking: 1392222

Apart from the other fields for submission, Box 5 only shows positive figures, as HMRC does not accept negative figures. Box 5 displays the summary of Boxes 3 and 4. The system calculates this field such that MTD takes the larger amount and deducts the smaller amount from it.

Incorrect Data on Entries if Tax Popup 1 Is Changed in the Tax Code

Deltek Tracking: 1416227

Previously, UK MTD disregarded Tax Popup 1 changes for tax codes relation to tax settlement entries. This error is corrected. UK MTD now considers the latest Tax Popup 1 change on tax codes. Note that tax codes should still have a distinction between Goods and Services/Non-Goods. This means that Tax Codes used for transactions on Goods should not be used for transactions on Services. See **Appendix C: Setup by Country » United Kingdom » UK PVA and RCM » Popup Field Setup** for more information.

Authorization Code Issue

Deltek Tracking: 1429796

Authorization codes are applicable to any company under the same client secret and client ID. However, VAT submission becomes an issue if the company's tax number is not a valid VAT Registration Number given by HMRC. Authorization codes are only valid for ten minutes before you can retrieve an access token. Once it becomes invalid, you need to retrieve a new authorization code again by logging in to the HMRC site.

Incorrect Data on Entries if There Is No Tax Popup 1 Setup on Tax Codes

Deltek Tracking: 1437085

Tax Popup 1 should be setup correctly in Tax Codes that are intended to be included for the UK MTD filing. Otherwise, incorrect amounts on boxes display in the report. See **Appendix C: Setup by Country » United Kingdom » UK PVA and RCM » Popup Field Setup** for more information.

NSAFT

Values Exceed Character Limit When Symbols Are Included

Deltek Tracking: 1412848

NSAFT truncates strings that exceed the character limit. However, if a string contained symbols such as ampersand (&), less than (<), and greater than (>), the characters were escaped which caused the string to exceed the character limit again. This error is corrected. In instances where the escaped value is truncated, the system removes the reserved character at the end of the string to avoid an invalid XML.

Journal ID Is Not Mapped to Journal No.

Deltek Tracking: 1412865

The <JournalID> element previously contained the hardcoded value 'A'. In line with the new requirement from the Norwegian Tax Administration, this is now mapped to **Journal No.** field.

Removal of <AnalysisTypeTable> in NSAFT

Deltek Tracking: 1412875

The <AnalysisTypeTable> and its elements are temporarily removed until the new structure is implemented.

Reserved Characters Are Not Encoded for General Ledger Entries

Deltek Tracking: 1413718

On the <GeneralLedgerEntries> part of NSAFT, values that contain characters such as ampersand (&), less than (<), and greater than (>) were not escaped correctly which resulted to an invalid file. This error is corrected. These reserved characters are now escaped as follows: ampersand to "&", less than to "<", and greater than to ">".

SupplierID and CustomerID Appear Simultaneously in Transaction Lines

Deltek Tracking: 1413725

Previously, SupplierID and CustomerID were derived from the **Customer No.** and **Vendor No.** fields of the finance entry. This resulted in the <SupplierID> and <CustomerID> showing on non-sub-ledger entries and sometimes appearing in the same <Line>. This error has been corrected such that only A/R or A/P sub-ledger entries have Customer or Supplier ID.

Tax Registration Number is Not Mapped to VAT Number

Deltek Tracking: 1413725

<TaxRegistrationNumber> previously was incorrectly mapped to the **Company Registration No.** This is now corrected and mapped to **Company Information Vat No.**

NSAFT Excludes Reconciliation Entries That Have Closing Date on the Statement Date

Deltek Tracking: 1441938

Previously, NSAFT excluded customer and vendor reconciliation entries that were closed exactly on the statement date. This error is corrected.

NSAFT Displays Supplier's Invoice as Debit Balances

Deltek Tracking: 1441977

The balances in debit vendor entries were incorrectly displayed as **Debit Balances**. However, these are liabilities. This error is corrected such that they are now displayed as **Credit Balances**. Thus, a credit entry increases the balance in Accounts Payable and a debit entry decreases the balance.

SIE

#VER Does Not Balance When Using Job Journal for Creating Multiple Transactions

Deltek Tracking: 1417443

#VER did not previously balance when the Job was selected in scenarios where the Entry Text was the same for all the transactions. Instance Key is now added but hidden in the report to create a more unique line.

Amounts Not Written Using Period as Decimal Delimiter

Deltek Tracking: 1417449

The SIE data export previously used the local settings to determine the decimal delimiter. This was incorrect as the delimiter should always be period. This error is corrected.

Software Issues Resolved – Application (APU)

Synchronous Notification Error When Description Has Special Characters

Deltek Tracking: 1428444

A receiver of synchronous notification previously encountered an error if the description shown in the notification view included any of the following special characters: ', ", and \. This error is corrected.

Empty FinanceEntryInstanceKey in the VendorEntry

Deltek Tracking: 1437841

Previously, the FinanceEntryInstanceKey in the VendorEntry table did not populate when you created, submitted, and approved a vendor invoice. This error is corrected such that it populates with the instance key of the corresponding finance entry on the A/P balance account.

Incorrect Draft Invoices for Auto-Calculated Surcharges at Invoicing on Account

Deltek Tracking: 1423701

Surcharge automatically calculated upon invoice on account selection approval previously did not calculate properly. The surcharge reduced the on account amount, rather than add to the on account amount. The error is corrected.

Vantagepoint Integration Dimensions Added Multiple Times to Requests

Deltek Tracking: 1412733

When previously running "Import Jobs and Customers from Deltek CRM", the list of fields was modified when adding dimension fields. When the request was run again, the fields were already in the field list but were added again. This continued until the fields were added so many times that Vantagepoint could not handle the request. This error is corrected.

Software Issues Resolved – Technology (TPU)

Find_<entity> Containers Not Available for Custom Entities

Deltek Tracking: 1440836

Previously, autogenerated find_<entity> containers were not available for any custom entities. This error is corrected.

Memory Leak When Using Arrays of Record Types

Deltek Tracking: 1428614

A server memory leak was discovered in Approval Hierarchies when used in conjunction with the Synchronous Notifications functionality introduced in Maconomy 2.5.1.

If large data imports were performed with this functionality enabled, the server process performing the import was at risk of running out of memory and terminating.

To mitigate the issue when performing large data imports, the synchronous notifications should be disabled by unmarking the "Synchronous Notification" field on notification types.

This error is corrected.

Cannot Obtain Business Objects Log Session Through RESTful API

Deltek Tracking: 1440771

Due to a regression introduced by an unrelated error correction, it was no longer possible to obtain a Business Objects log session through the Maconomy RESTful API. As a result, it was not possible to run Business Objects reports from iAccess. This error is corrected.

ArrayIndexOutOfBoundsException When Using IME in Workspace Client

Deltek Tracking: 1426773

When using Chinese IME, the Workspace Client previously often crashed with a 'java.lang.ArrayIndexOutOfBoundsException' error displaying. This error is corrected.

Software Issues Resolved – Tooling

Duplicate Timestamp Triggers

Deltek Tracking: 1420904

2.5.1 came with a script for creating timestamp triggers which used incorrect names. This could lead to duplicate triggers. This error is corrected and will ensure that the triggers with incorrect names are removed in the database.

Software Issues Resolved – iAccess

Data Changed Error in Time Sheets Triggered by Change in "timeoflatestchange" Field

Deltek Tracking: 1433468

Browsers: IE11, Chrome, Safari, and Firefox

If users working in the Weekly and Daily Time Sheets workspaces left the web page idle for 10 minutes, iAccess displayed the "Data was changed by another user" error message. This is now corrected.

Configurations Cache in REST API Cannot Be Invalidated

Deltek Tacking: 1442513

The following is part of 2.5.1 CU 6:

1. The in-memory caching of compiled configurations in the Configurations Web Service can now be disabled by including the following setting in server.ini (default value is true):

```
web.services.maconomy-configurations.cache.enabled = false
```

2. A call refreshing client configuration data is now done on each Configurations Web Service request. Together with the following setting in server.ini, this entails that any in-memory cached compiled configurations are invalidated, if the MCIL file has changed:

```
cache.client-configuration.update-on-request = true
```

With the above described two changes, it should be possible to avoid having to restart the Coupling Service each time one needs a layout change to take effect during a development process.

In a live system, the configurations cache should always be enabled, and the update-on-request setting should be set to false.

Known Issues

Incorrect Data in UK Tax Submission WEBI Report

Defects: 1434455, 1428074, 1434523, 1401884

UK Tax Submission WEBI Report has multiple issue. While the bugs are not of a high severity, there will be issues running the report, including:

- On the Tax Details tab of the UK Tax Submission report in Webi, box 1 data is incorrect, as it does not contain data from a UK Company, a EU/ROW Customer using NIR Tax Code, or from the NIRE Company EU/ROW Customer with Tax Popup Services.
- On the Tax Details tab of the UK Tax Submission report in Webi, box 1 data has incorrect amounts due to the following scenarios:
 - When ROW transactions have tax code of Service RCM
 - When Using NIR tax code with any popup from an EU Customer
 - When Customer Invoices under NIR company and EU/ROW customer for Services
 - When Customer Invoices for UK and NIR have Goods/Services Tax Popup

SIE: File Includes Accounts Not Part of the Selection Criteria/Period

Defect: 1441799 (Sev 3)

Some SIE files show accounts even if they are not part of the selection criteria/period.

Format Error in Tax Return CA3 Report

Defect: 1381495 (Sev 3)

In the Tax Return CA3 (France statutory) report, when data does not exist on a specific Tax Code, #,##0.00 shows instead of 0.00.

Cash Flow Statement Report Navigation Error

Defect: 1405951 (Sev 2)

When deploying SPUs for 2.4.5, an error is encountered when you navigate to Reporting -> Reports and clicking the Cash Flow Statement report. This is because the dialog layout within the SPU still references the BPM Report "Cash Flow Statement" when it should reference the renamed title "Cash Flow Statement with Budget." Although the report is still accessible via standalone BI Launchpad, it is inaccessible when running it within the WSC.

Workaround: Note that this error is encountered if an SPU is deployed. As a workaround, use a Maconomy instance without a deployed 2.4.5 SPU.

Incorrect Formula for TotalTaxVendor in Tax Details Tab

Defect: 1441800 (Sev 3)

From the Tax Details tab of the UK Tax Submissions report, the Box 4 amount was not previously considered in the totals from the TotalTaxVendor field. Box 2 and Box 7 were added together in the formula when Box 4 + Box 7 should provide the total instead.

GL Accounts Show Entries Not Part of the Period

Defect 1413859, 1450307 (Sev 2)

Entries for General Ledger accounts that are not in the selected period are sometimes included in the balance.

CurrencyCode is Included Even if the Entry Has the Same Currency as the Header Company

Defect 1397209, 1450304 (Sev 3)

Currently, currency code field is always included in the extract, regardless if it is the same as the currency of the header company. It should only be included if the entry has a currency different from the header.

GL Entries Excluded with Dates in Different Years

Defect 1410659, 1450304 (Sev 2)

GL entries are excluded in the NSAFT file when the Selection Criteria includes beginning and end dates in different years.

NSAFT

Truncated XML Occurs Even When Background Task is Successful

Deltek Tracking: 1338440

An unknown error not written on the logs previously caused the generated XML to be truncated on the customer data even if the background task finished successfully. This error is corrected.

Important: The following parameter should be added to the Maconomy server.ini file in order to improve performance.

- `filepath.nsaftoffset = 50000`

Note that the value (here, 50,000) can be adjusted as needed. This is the general recommendation for a starting point but can be changed as desired. This is especially important to note if the background task experiences database timeouts during execution.

Missing Elements on NSAFT File

Memory Leak in Maconomy Server

Long-running application actions with many database queries previously resulted in a gradual increase of memory consumption in the Maconomy server process. As of January 1, 2021, HMRC has approved certain changes to the VAT 100 form that have an impact on UK MTD and filing procedures. These changes are related to new requirements for VAT on imports.

Changes to Maconomy

UK MTD functionality is updated to accommodate **Postponed VAT Accounting (PVA)** and **Reverse Charge Mechanism (RCM)** functionality for the VAT-100 form as detailed in the following sections. PVA and RCM represent exceptions to normal VAT charges that must be handled according to HMRC protocol. These are explained in the sections below. Links to procedures for completing each type of transaction are provided as necessary.

Normal VAT Charge

Note: All tax amounts are the *deductible* tax amounts.

Box Definitions and Uses

The following are the boxes available to be used for normal VAT charges.

Important: As of 1/1/2021, boxes 2, 8, 9 will only be used for transactions with Northern Ireland, which remains part of the EU and not impacted by BREXIT. These boxes will no longer be used for any other UK or “rest-of-world” transactions. They are displayed in gray below.

These fields will default to zero for all “rest-of-world” countries except Northern Ireland.

Please note changes to the wording of these box descriptions:

- **Current wording:**
 - Box 2: VAT due in this period on acquisitions from other EC Member States
 - Box 8: Total value of all supplies of goods and related costs, excluding any VAT, to other EC Member States
 - Box 9: Total value of all acquisitions of goods and related costs, excluding any VAT, from other EC Member States
- **New wording** (as of 1/1/21):
 - Box 2: VAT due in this period on intra-community acquisitions of goods made in Northern Ireland from EU Member States
 - Box 8: Total value of intra-community dispatches of goods and related costs (excluding VAT) from Northern Ireland to EU Member States
 - Box 9: Total value of intra-community acquisitions of goods and related costs (excluding VAT) made in Northern Ireland from EU Member States

Postponed VAT Accounting (PVA)

Postponed VAT Accounting, or **PVA**, allows businesses to account for VAT in imports through their periodic VAT return instead of having to pay that VAT at or upon crossing the UK border.

The Postponed VAT Accounting rules or PVA come into effect on January 1, 2021. The new rules combine the former customs reports for goods received from the EU (before BREXIT) and the rest of the world (ROW) onto the VAT 100 form impacting boxes 1,4 and 7 (in most instances) and the MTD filing.

Box Definitions and Uses for PVA

In light of Brexit, HMRC has introduced a new method of accounting for import VAT in the VAT return. This could have a compulsory requirement for some businesses to follow these rules. Under this rule, when a business import goods – either from an EU or a non-EU country:

- It could pay import VAT to HMRC through its VAT return.
- In Addition, similar to the current rule, businesses can seek to recover this import VAT as input tax in Box 4 of the VAT return. The value of import is shown in Box 7.

The table below shows the specific boxes to be populated for PVA:

Important: After Brexit, on 1/1/21, box 9 will only be used for transactions with Northern Ireland from EU member states. It will no longer be used for any other UK or “rest-of-world” transactions. This box is displayed in gray above.

Additionally, box 9 is currently incorrectly populated for “rest-of-world” countries. Note that this will no longer be an issue after Brexit as box 9 will only be used by EU member states.

Reverse Charge Mechanism

Reverse Charge Mechanism, or **RCM**, is used to categorize transactions that are for “reverse charge” in accordance to HMRC’s mandate.

Under the reverse charge procedure, the buyer of the goods or services, rather than the seller, is liable to account for the VAT on the sale.

This rule combines different types of transactions received from the EU (before BREXIT). Boxes 1, 4, 6, and 7 will be impacted in accordance with how input and output tax will be handled for MTD filing.

Update Synchronization Between Vantagepoint and Maconomy to Use Long Project Name Instead of Short Project Name

In Vantagepoint, there is a short project name and a long project name. The short project name can contain up to 40 characters, while the long project name can contain up to 200 characters. The integration with Maconomy 2.5.1 previously synchronized to the short project name. This meant that the job name in Maconomy and the job name that was being sent back to Vantagepoint could be cut off at 40 characters. This particularly impacted customers using their CRM integration to work with projects in Vantagepoint 3.x instead of opportunities.

This update changes the feature to allow synchronization with the long project name, allowing the name to be up to 200 characters in length.

This error is corrected.

On Vendor Invoice Creation you can specify a custom description. Description is a required field, and if you do not wish to set it manually, then the system parameter “Suggest Company Vendor Name as Entry Text” can populate it automatically.

For Batch Self Invoicing, it was previously not possible to provide a custom Description without the system parameter. This error is corrected.

Duplicate Entries in Job Payment Information Table

Deltek Tracking: 1325154

Printing a blanket credit memo on account previously led to duplicate records in the Job Entry Payment Information database table. This error is corrected.

Software Issues Resolved – BPM

UK MTD Does Not Enforce Company Country Restriction

Deltek Tracking: 1271714

The UK MTD report did not previously restrict entries where the Country of the Company was not in the United Kingdom. When the **Company Country** field was populated with a value other than "United Kingdom (UK)", the report still retrieved entries and populated the table. This error is corrected.

NSAFT: Error in Pagination Handling

Deltek Tracking: 1329250

NSAFT previously handled pagination incorrectly. Instead of only performing one query and then processing a set of records based on the offset value, NSAFT re-ran the query for every 200 records pulled. This resulted in very slow performance. This error is corrected.

NSAFT: Multiple Transactions Appear with Same Transaction Number

Deltek Tracking: 1324375

In Maconomy, a journal previously showed multiple transactions with the same transaction number. Duplicate transactions appeared in the generated XML due to incorrect grouping of transaction headers. However, NSAFT requires that all transaction numbers are unique. This error is corrected so that multiple transactions no longer display the same transaction number.

Native App Support to Securely Log in to Maconomy via Azure

Deltek Tracking: 1317901

The OpenID Connect (OIDC) login modules (MaconomyOIDC and MaconomyAzureOIDC) were not able to previously consume OAuth Bearer tokens. This meant that it was not possible to use other OAuth login flows in parallel with the OIDC Client Credentials flow.

The RESTapi will now accept Bearer tokens when an OIDC login module is configured, and the OIDC login modules are able to process these tokens, if they are valid Jason Web Tokens (JWT).

Depending on which login flow is used to obtain the bearer token, the list of accepted user identity claims (specified in the 'userIdentity' login module parameter) might have to be adjusted, to include the claim that contains the caller's identity.

Search for Container Fields on Scheduled Rule Error

Deltek Tracking: 1337959

When previously defining Container Fields on a Scheduled Rule for a table pane rule in the Background Task framework, the search returned a table field. This was incorrect. This error is corrected. Now, a search for Container Fields on a Scheduled Rule for a table pane will now return card fields.

MScript Session Returns Error After 5 Minutes of Inactivity

Deltek Tracking: 1320337

If you do not use the MScript session for 5 minutes or longer, Maconomy returns a “could not reconnect, login session not valid” error. This error is corrected.

Export to Excel Error in Java Analyzer

Deltek Tracking: 1321625

Previously, an error occurred when attempting to export in Simple Excel 2003 or Simple Excel 2007 format in Java Analyzer. This error is corrected.

Error When Changing Password in Touch or iAccess

Deltek Tracking: 1341421

An error previously occurred when you attempted to change your password in Touch or iAccess. This error is corrected.

Delay Checking Previously-Used Passwords

Deltek Tracking: 1320193

Checking previously-used passwords previously took 7-8 seconds to display in the Workspace Client. There was no progress bar to alert the user that this process was occurring. This error is corrected.
