## Software Issues Resolved

### General

License – Incorrect Subscription Expiration Date

**Deltek Tracking No.** 1593714

**Description:** If multiple application instances were running on the system, it did not automatically update license values. As a result, only one server got the valid license. If any users then encountered a server other than that one, they were logged out.

## Features and Enhancements Added or Changed

### Finance & Administration

Invoices – Posting Invoices Imported through the MAS500 Integration in Project Postings

Previously, you could not post invoices that were imported via the following API endpoints for the following reasons:

- AR and AP invoices that were imported through the MASARInvoice and MASAPIInvoice API endpoints were created with journal number -1.
  - AR invoices that were imported through the MASARInvoice API endpoint were imported with a currency conversion rounding error when converting from invoice currency to company currency, which could cause the resulting journal to not balance.
  - AR invoices that were imported through the MASARInvoice API endpoint were imported without a sales tax code.

## Known Issues

### Jobs

Costs – Purchases – Move Job Voucher – WorkBook does not Block Move to Job where Needed

**Deltek Tracking No.** 1608477

**Description:** When you move a voucher that does not have a Finance account to a job whose Expenditure account is set to Needed, WorkBook does not block the operation.

## Software Issues Resolved

### Finance & Administration

Vouchers – Cannot Move Vouchers that do not have Finance Accounts between Jobs

**Deltek Tracking No.** 1583114

**Description:** When you tried to move a voucher that did not have a Finance account to a job where the Expenditure account was not set to Needed, WorkBook blocked the move operation.

---

## General

Error when Accessing WorkBook through Browser on Mobile Device

**Deltek Tracking No.** 1583104

**Description:** When you accessed WorkBook in a browser on a mobile device, you encountered an error when you logged in. This error was encountered beginning with version 13.0.

**Additional Notes:** This error only occurred when you accessed WorkBook in a browser on a mobile device. It did not occur when you used the WorkBook mobile app.

License – Incorrect Subscription Expiration Date

**Deltek Tracking No.** 1593714

**Description:** When you went to Settings » License Management, the subscription expiration date did not display the correct license expiration date.

## Jobs

Price Quote (PQ) – Lines – System Issue Error

**Deltek Tracking No.** 1591007

**Description:** When you edited a PQ line and saved, an error occurred.

Tasks – Cannot Book New Employee because of Missing Capacity Profile

**Deltek Tracking No.** 1594421

**Description:** You could not book employees if they did not have capacity profiles at the start of the task period.

**Workaround before Fix:** Add a new task on the job and book the employee there.

## Resources

Absence Reports – Report 173 (Holiday Yearly Overview) and Report 188 (Holiday Specification – Year) – Danish Holiday Act – Only Absences from Current Holiday Period are Displayed

**Deltek Tracking No.** 1592556

**Description:** When you ran Reports 173 or 188 on a company that uses Danish Holiday Act, and two holiday periods overlapped on the period, only absences from the current holiday period were displayed.

**Workaround before Fix:** Block the vacation year or transfer unused vacation.

**Additional Notes:** Added the **Danish Holiday Act: Base Holiday Period on Vacation Year** option to allow for previous behavior, if only one holiday period is expected.

## Tasks

Add Task – Cannot Delete Costing Code when Company Variable is Set to 2

**Deltek Tracking No.** 1594416

**Description:** On the create task and ticket dialogs, you could select a costing code but not remove it again, if Company Variable was set to 2 (Required on Jobs, Optional on Tasks).

**Workaround before Fix:** Close the dialog and reopen it or remove the costing code after creating the task or ticket.

## Software Issues Resolved

### Email

TLS Error when Sending SMTP Emails

**Deltek Tracking No.** 1592542

**Description:** Some email providers such as Office365 only work on TLS1.2. This caused WorkBook to be unable to send emails.

**Additional Notes:** WorkBook now uses TLS1.2 as the default for sending emails.

## Known Issues

### Finance & Administration

Vouchers – Cannot Move Vouchers that do not have Finance Accounts between Jobs

**Deltek Tracking No.** 1583114

**Description:** When you try to move a voucher that does not have a Finance account to a job where the Expenditure account is not set to Needed, WorkBook blocks the move operation.

---

### General

Error when Accessing WorkBook through Browser on Mobile Device

**Deltek Tracking No.** 1583104

**Description:** When you access WorkBook 13.1 in a browser on a mobile device, you encounter an error when you log in using WorkBook version 13.1.

**Additional Notes:** This error only occurs when you access WorkBook 13.1 in a browser on a mobile device. It does not occur when you use the WorkBook mobile app.

---

### Tasks

Add Task – Cannot Delete Costing Code when Company Variable is Set to 2

**Deltek Tracking No.** 1591535

**Description:** When you create a task, you can select a costing code. However, later you cannot remove it—there is no **x** button—if Company Variable is set to 2 (Required on Jobs, Optional on Tasks).

Time Entry Timer – Cannot Stop the Timer unless the Job and Task have Valid Costing Codes (If Required)

**Deltek Tracking No.** 1581437

**Description:** When Company Variable 73 is set to 3, and you stop the timer on a time entry that has a job and task that do not have a valid costing code, WorkBook displays the following error message: **No jobs with costing codes. Please refer to company variable 73.**

## Time & Expense

Timesheet – Change Task Drop-Down does not Filter on Costing Code

**Deltek Tracking No.** 1583234

**Description:** When you change a time entry's task, and Company Variable 73 is set to 3, tasks that have invalid costing codes are still displayed in the Task drop-down list.

Timesheet – Costing Codes are not Marked Invalid on Timesheets

**Deltek Tracking No.** 1588452

**Description:** When Company Variable 73 is set to 1, 2, or 3, and the costing code that is assigned to the job/task on your time entry does not have Company or Client access, the costing code value on the timesheet grid is not highlighted in red.

Expense Entries Message Displayed when You Change Creditors with Different Companies when Task is Set

**Deltek Tracking No.** 1591074

**Description:** When you try to change the selected creditor for an expense entry to a creditor of another Company, WorkBook displays an incorrect error message that the Company does not exist or is not active, if you already added a job and task to the respective fields of the expense entry.

**Workaround before Fix:** Clear the expense entry's Task field. You can then change the creditor.

---

## Software Issues Resolved

### Finance & Administration

Creditors - Creditor Invoices – Costing Codes do not Validate Creditor Invoices when Company Variable 73 Value is 1 or 2

**Deltek Tracking No.** 1581511

**Description:** When Company Variable 73 was set to either 1 or 2 and optional on a job or task, costing codes were not correctly validated on creditor invoices. You needed to validate the correct use of costing codes as if it were mandatory.

**Customers Impacted:** Customers who use costing codes:

**Workaround before Fix:** Set the value of Company Variable 73 to 0 or 3, instead of 1 or 2.

Creditors – Creditor Invoices – Invalid Tasks are not Displayed in Parentheses

**Deltek Tracking No.** 1583071

**Description:** When tasks became invalid in creditor invoices because costing code setups were updated, those invalid tasks were not displayed in parentheses.

**Customers Impacted:** Customers who use version 13.1.

---

Creditors - Creditor Invoices – Job Drop-Down in Sub-Grid does not Find any Jobs when Company Variable 73 Value is 1

**Deltek Tracking No.** 1581527

**Description:** When costing codes were set to be optional on a Company, the job drop-down in the creditor invoices sub-grid lines did not contain any jobs.

**Customers Impacted:** Customers who use Company Variable 73 set to 1 (optional on jobs and tasks).

**Workaround before Fix:** Set Company Variable 73 to a value other than 1 (optional on jobs and tasks).

**Additional Notes:** Costing codes are controlled by Company Variable 73.

Creditors - Creditor Invoices – Job Drop-Down in Sub-Grid does not Find any Jobs when Company Variable 73 Value is 2 or 3

**Deltek Tracking No.** 1581526

**Description:** When Company Variable 73 was set to 2 or 3, you could not access jobs in the creditor invoices sub-grid if those jobs had costing codes defined for them.

**Customers Impacted:** Customers who use costing codes with Company Variable 73 set to 2 or 3 on version 13.1.

Creditors - Creditor Invoices – Job Selection does not Validate Costing Codes Level Setting

**Deltek Tracking No.** 1581517

**Description:** When you changed a costing code level, the costing codes were not correctly validated in creditor invoices. Any open item should indicate that there is an invalid costing code with a red highlight; you should not be able to approve these because validation of the costing code should fail.

**Customers Impacted:** Customers who use costing codes.

**Workaround before Fix:** Create costing codes with level 2.

Creditor Invoices – Task Selection does not Validate Costing Codes Allow on Task Setting

**Deltek Tracking No.** 1581520

**Description:** When a costing code setup was updated on the task level, tasks with that costing code applied on creditors' invoices were not highlighted in red and in parentheses when they were displayed.

**Customers Impacted:** Customers who use version 13.1.

---

---

## General

Database Transactions do not always Work

**Deltek Tracking No.** 1583205

**Description:** When you performed certain actions, an error could occur that caused WorkBook to automatically retry the action in an invalid state. This could cause data to not be saved properly. This included, but was not limited to the following:

- Time entries being posted on an empty journal.
- Job creation with the automatic assignment of a job number failing because the assigned number was already in use.

## Jobs

Jobs List View – Incorrect Values Displayed in Actual Sales and Actual Cost Columns

**Deltek Tracking No.** 1583481

**Description:** When multiple users add time entries in a job or multiple jobs, incorrect values are displayed in the Actual Sale and Actual Cost columns in the grid.

Purchase Order – Purchase Order (4) Report – Costing Code Columns not Displayed

**Deltek Tracking No.** 1583178

**Description:** When you generated a Purchase Order (4) report as an XLSX document (row data), job and task costing code columns were not displayed.

---

## Settings

Company Variables – Company Variable 73 Set to 1 or 2 does not Work Correctly

**Deltek Tracking No.** 1570695 and 1583486

**Description:** When Company Variable 73 was set to 1 or 2, the expense type setting for the costing code was not validated on jobs and tasks. As a result, jobs and tasks that contain costing codes that do not allow that expense type entry were not filtered out of drop-down lists.

---

## Time & Expense

Timesheet – Change Task Drop-Down does not Filter on Costing Code

**Deltek Tracking No.** 1583234

**Description:** When you change a time entry's task, and Company Variable 73 is set to 3, tasks that have invalid costing codes are still displayed in the Task drop-down list.

Timesheet – Costing Code Approval

**Deltek Tracking No.** 1580601

**Description:** When you submitted a time entry with a job/task that did not have a valid costing code assigned to it, the time entry went for approval. WorkBook did not block it, regardless of the value of Company Variable 73.

## Software Issues Resolved

### Finance & Administration

Creditors – Creditor Invoices – Voucher Preview was Displaying a Black Page

**Deltek Tracking No.** 1570331

**Description:** When you downloaded or previewed a voucher attachment that was stamped and opened it, its file size was much larger than when it was uploaded, and a black page might be displayed.

**Customers Impacted:** Customers on version 13.1 who stamp their voucher files.

**Workaround before Fix:** Set System Variable 950 to 1.

Creditors – Creditor Invoices – Patching Job Caused a Deadlock in #C

**Deltek Tacking No.** 1570316

**Description:** When you attempted to update or change the job dimension on the detail line of a creditor invoice, it would go into a deadlock, which prevented any update to the job field.

**Customers Impacted:** Customers on version 13.1.

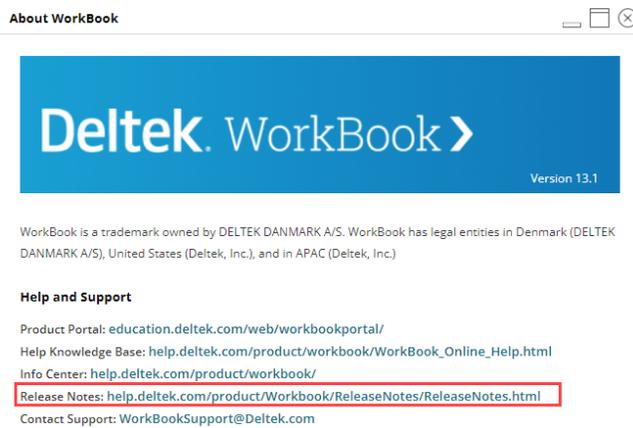

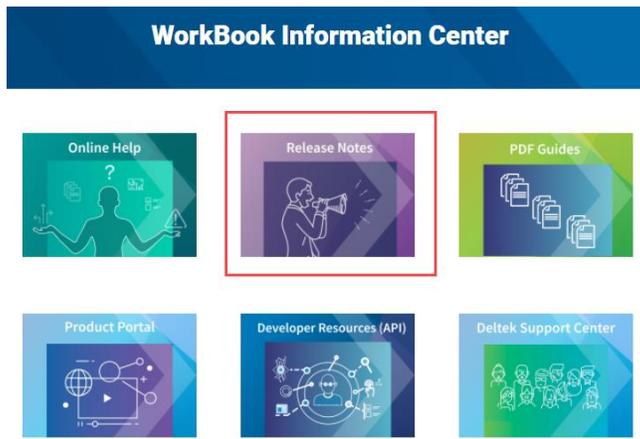
## Online Release Notes

## Session Notifications Reliability Improvements

The way that WorkBook handles large volumes of notifications has been improved—for example, when users are notified simultaneously about data changes made by other users.

### Costing Code Column Added

A Costing Codes column has been added to the following Job List views to show the costing code assigned on jobs:

- Simplified Job List
- Job List (1)
- Status Report (2)

This column has also been added to the tasks grid.

### Improved Performance of Job Key Figures Recalculations

Recalculation of Job Key Figures—time entries, material entries, and creditor entries—has been improved. These recalculations are now up to 15% faster.

---

## Reports

### Report 263 (Employee Holiday and Flex) – General Improvements on Report Generation

When you generate Report 263 it displays only resource information that is based on your cross-company access setting Access to Employee.

---

## Resources

### Employee Card – Prevent Disabling of Employees who have not Entered Time or who have their Time Entries Approved

Because open time entries made by disabled employees can cause issues, an additional barrier for disabling employees is added. To deactivate employees, they must now complete their timesheets for all past dates in open accounting periods, and all time entries must be approved, which is similar to other cost entry types such as expense and mileage.

**Tip:** While this is only performed for employees who must enter timesheets, it can also potentially affect employees who cannot log in to WorkBook, as well as Group Scheduling Resources, if they are set to enter timesheets. To avoid this, disable the User Must Enter Timesheet option to skip the check on time entries if, in fact, these employees are not required to enter time entries.

Days that have incomplete time entries are for all open accounting periods for the Company, even if they do not appear on the missing time entries page for the user.

---

## Scheduling

### Task Matrix – Allow Adding Employees to Tasks that They are already On

WorkBook provides multiple ways to add employees to tasks. One limitation was the inability to add an employee who was already on a task, which was not necessarily obvious from the dialog. When there is no particular reason to prevent an employee from being added to the task, increasing the number of hours that the employee is already booked on that task is often appropriate. When you increase the hours, a message is shown that specifies how many hours that employee was already booked on for that task, in case that is not what you wanted.

There is a limitation to this feature regarding employees who are marked as done. If the hours that are added are provided through automatic booking (just increasing the number of hours for which the employee is booked), you can add the hours, and the employee is marked as active on the task. However, if manual booking exists on that employee, or you want to add manual bookings, it is not clear how the original hours must be handled. As a result of this situation, dialogs might not allow adding hours to an employee who is marked as done. Addressing this issue is under discussion.

**Attention:** This functionality is also added to the Calendar and Timeline Calendar views.

### Tasks – Improved Performance of Task Deletion

Performance of task deletion has been improved. Deleting a task is now up to 25% faster.

## Settings

### System Variables – System Variable 302 has been Removed

System Variable 302 (WorkBookAutoUpdate) has been removed because automatic update of WorkBook systems is not currently supported. Applying updates requires manual actions. You should plan updates with Deltek staff (for hosted systems) or internally (for on-premises systems).

### System Variables – System Variable 883 has been Removed

System Variable 883 (PaymentScheduleInvoiceNotificationOnJob) has been removed because it was not functional. The existing Agent Type 103 provides the same functionality. Agent Type 103 is documented in Knowledge Base Article (KBA) 105024, Agent Type 103 – Notification: Price Quote Payment Scheme Send Simple Reminder, in the Deltek Support Center.

## Tasks

### Task Card – Task Resources – Search Field Added

A search field is added to the task resources page for task resource list and matrix views. This search field works similarly to search fields on other grids elsewhere in WorkBook.

---

## Time & Expense

### Time Entry – Red Background for Invalid or Missing Costing Codes

When a costing code is invalid for a time entry, the costing code is shown with a red background. The costing code column can also be shown with a red background if a Company's setup requires that a costing code must exist on tasks and/or jobs, but there is no costing code for the time entry.

Only customers who use costing codes are affected by this enhancement.

Company Variable 73 determines the marking of time entries that do not have associated costing codes.

### Timesheet upon Login Popup Window – Maximize / Restore Option

You can now use the maximize / restore window size option on the Timesheet upon Login pop-up window.

---

## User Interface

### Inbox Contents – Inbox Redesign

The inbox contents padding/spacing has been increased between header titles, drop-downs, and icons. The Classic Style and Modern Style conversation options have been merged into a cleaner, fresher style known only as the Modern Style. Within the card left navigation toolbar, the available options/icons now appear in a darker color when selected. This color is consistent with the default or the selected color recipe. This provides better visibility.

**Description:** When you edit the Activity field on the imported personal expense, you can select an activity that is not allowed for personal expense.

Grids – Numeral 1 Displayed Next to Sort Indicator

**Deltek Tracking No.** 513129

**Description:** When you sort columns in grids, the numeral 1 is displayed next to the sort indicator.

---

### Jobs

Price Quote (PQ) – Line – Copy / Paste on Last Cell or Empty Cell Adds Multiple Empty Lines

**Deltek Tracking No.** 512652

**Description:** When you copy empty cell(s) then paste them back into grids, it might cause unexpected results. This is caused by an upgrade of the grid component.

**Workaround before Fix:** Do not copy empty cells and then paste them back into grids.

Sales Invoice – Toolbar Tabs are not Displayed when You Minimize the Page

**Deltek Tracking No.** 513253

**Description:** The toolbar can have missing tabs when the window is too small.

**Workaround before Fix:** Try making the window bigger, or close the job sidebar.

Language & Formatting Options – Formatting – Drop-Down Fields Look too Narrow and have no Values

**Description:** The drop-down lists for Time and Date formats that are found in Language & Formatting Options under My Settings are not shown in their full width, and their values are missing.

Company Variables – Company Variable 73 – Invalid Expense Types do not Filter Costing Code Drop-Downs

**Description:** When Company Variable 73 is set to 1 or 2, the expense type setting for the costing code is not validated on both jobs and tasks. This means that jobs and tasks that contain costing codes that do not allow the expense type entry are not filtered out of drop-down lists.

Dashboards – Line Layout Settings not Applied when You Create a Dashboard

**Description:** When you add a dashboard from the Dashboard Overview Page using the Add a Dashboard button, the settings of the dashboard, such as design layout, are not saved.

Attached Job Documents Disappear after Update to Release 13.0

**Description:** If System Variable 684, Job Folder Name Job Number Place, has a value of 2—Set Job Number after Job Name in the Folder Name (in Parentheses)—it causes jobs that were created before Release 13.0 to have hidden job folders.

## Tasks

Time Entry Timer – Cannot Stop Timer unless Job and Task are Set Up with a Valid Costing Code when Company Variable 73 Requires It

**Deltek Tracking No.** 513214

**Description:** If Company Variable 73 requires a costing code—that is, it is set to option 2 or 3—but the job or task does not have a valid code for time entry, you cannot stop the time entry timer before the job or task setup is corrected.

**Workaround before Fix:** Set Company Variable to option 0 or 1. This corrects the job or task setup. However, the ability to do this might be limited to certain user types.

Pipelines – System Error Constantly Occurring

**Description:** When as an Advanced User with restricted access you tried to access the Pipelines page, you encountered a System Issue error dialog.

**Additional Information:** This error now displays an appropriate information dialog.

### Finance & Administration

Creditor Invoices – Cannot Preview or Download Creditor Invoice File or Expense Entry Receipt

**Deltek Tracking No.** 511595

**Description:** When you previewed a voucher attachment or downloaded a voucher attachment while the voucher number was being stamped on the attachment, you might have been unable to preview or download the file.

**Customers Impacted:** Customers who have set System Variable 950 to any value other than 1 might experience this issue when previewing or downloading voucher attachments.

**Workaround before Fix:** Set System Variable 950 to 1 temporarily; however the voucher number then disappears.

**Additional Notes:** If you set System Variable 950 to 3, the voucher stamp reappears.

Creditor Invoices – Costing Codes Cost Entry Validation

**Description:** Creditor invoices did not take Company Variable 73 into account when you added a job to detail lines or when you created a creditor invoice with an attached purchase order. As a result, WorkBook did not validate whether or not the job was allowed to be used on the creditor invoice.

## Creditor Invoices – Intercompany Transactions Display Wrong Currency

**Description:** When you created an intercompany expense transaction between two companies that had different base currencies while System Variable 909 was enabled, the resulting creditor invoice in the owner company had the same amount in company currency as the creditor invoice in the job company, in spite of being in a different currency.

## Creditor Invoices – Quick Edits in Grid Stop Edit Mode

### **Deltek Tracking No. 513033**

**Description:** When you made quick edits of values in the grid, the grid left edit mode. This made it necessary for you to enter some values twice.

## Debtor Invoices – Electronic Delivery – Electronic Invoice UBL has Hard-Coded Tax Category

### **Deltek Tracking No. 512293**

**Description:** When a UBL electronic invoice's tax was 0%, its tax category was automatically set to standard-rated (StandardRated), rather than the correct value, zero-rated (ZeroRated).

**Customers Impacted:** Customers who use electronic invoicing UBL on invoices with 0% tax.

**Workaround before Fix:** Manually edit the generated XML file to change the tax category field value from StandardRated to ZeroRated.

**Additional Notes:** The value of the tax category field is now set appropriately to StandardRated or ZeroRated, depending on the VAT % on the invoice.

## Debtor Invoices – Debtor Balance by Age 0-180+ Days Report (Report 550) Shows Different Invoice Date

### **Deltek Tracking No. 511126**

**Description:** For at least one of the involved Companies, Report 550 showed the invoice date of an invoice that had the same number, but was in another Company.

**Customers Impacted:** Customers who use multiple Companies.

## Revenue Forecast – EAC Calculation Includes Value in Remaining Following Years

### **Deltek Tracking No. 510880**

**Description:** When you cancelled a price quote that was used in revenue forecasts, forecasting using the EAC method, and the forecast had actuals for the job, updating the forecast correctly removed the forecast and evened out the actuals using the forecast, but incorrectly added the actuals back into the remaining following years column.

Conversations – Error when Loading Conversations with Reference Type 176

**Description:** When you opened the Inbox, and you had a conversation with reference type 176 in the Inbox list, an error popped up when you loaded the page.

**Customers Impacted:** Users who have conversations with reference type 176 in their Inbox lists.

Notifications – Failed Login Attempts Create One Conversation for each Failed Attempt

**Deltek Tracking No.** 511291

**Description:** When you had a failed login attempt, WorkBook created a conversation, which caused spam.

**Additional Notes:** WorkBook now sends a new comment, aggregating errors, instead of creating another conversation.

Cannot Change Status for New Jobs

**Deltek Tracking No.** 509450

**Description:** When you changed a job status using the grid, an error sometimes occurred, and the System Error dialog was displayed.

**Additional Notes:** This error appears to primarily affect Macintosh users.

Client Group Dimension does not get Default Value when You Create a Job

**Deltek Tracking No.** 510159

**Description:** When you created a job, the Client Group dimension did not get a default value, nor was it updated, based on the client.

Create New Job – Error Occurs

**Deltek Tracking No.** 511752

**Description:** When you tried to create a job, an error occurred, and the System Error dialog was displayed.

Price – Lines – Dimension Cells are Frozen on New Lines

**Deltek Tracking No.** 510686

**Description:** When you added a new line, you could not edit dimension cells.

Price Quote (PQ) – Error when Moving Lines

**Deltek Tracking No.** 510797

**Description:** When you moved lines on a PQ with purchases, a Sentry error occurred, and changes were not applied.

Price Quote (PQ) – Billing Plan – Error when Viewing Billing Plan on Approved PQ

**Description:** When you navigated to the billing plan page of an approved PQ, the following error occurred: **The price quote is locked for changes.**

**Description:** You could not delete a schedule from a job, even though you deleted it from the job template.

Tasks – Booked Resources – Approval Status Button Requires Soft Refresh

**Deltek Tracking No.** 509482

**Description:** when you clicked the Booking Approval Status button of a selected booking, the booking status did not change automatically until you did a soft refresh of the page or navigated away from the page.

Tasks – Report 94 (Allocated Hours / Used Hours) – Job Number is Cut Off

**Deltek Tracking No.** 513105

**Description:** When you generated Report 94, job numbers that have more than five digits were cut off.

Login History is not Displayed Correctly

Employee Task Summary – Sub-Grid – Task Grid View – Job or Job Name Column Header does not Sort Data

**Description:** When you tried to enable Private Withdrawals in the main grid by selecting the check box, and then you refreshed, the check box reverted to being not selected.

Report Attachments – Uploading an Attachment Causes Error

**Description:** When as an Advanced User you tried to upload attachments, an error occurred.

**Workaround before Fix:** Have an Admin User upload the attachment, instead of an Advanced User.
