General Application Enhancements

Update Dates on Budget Summary Lines

Deltek Tracking: 1421839

- This feature provides the option to allow sum/text lines on a budget with a tree-like structure to display start and end dates on several fields only when all sublevel lines have provided a date.

Resource Planning Workspace

Deltek Tracking: 1489505

- A new workspace is added to the Workspace Client and iAccess to support a multi-job view of job resourcing.

The Conversation Center

Deltek Tracking: 1283581

- The Conversation Center builds on existing conversations functionality by providing users with a centralized workspace where they can view, tag, and respond to any conversation in which they are a participant.

Statutory/BPM

Germany Elster USTVA and Permanent Filing

Deltek Tracking: 401745

- The Elster USTVA report is introduced. This report allows you to produce multiple XML files based on VAT-related entries.

NSAF-T Report: Consolidate Companies into Single Report

- You can now consolidate multiple companies into a single N-SAFT output report.

NSAF-T: Include Master Data Outside of Selection Criterion Range

Software Issues Resolved

Application >> Back Office

Defect 1488843

Tax Settlement Could Have Negative Month

In Tax Settlement you are able to trigger a negative month, such as -5 / 2021. This would happen if you created and approved a Tax Settlement starting in one year and ending in the next. This is now fixed and available to use all years.

Defect 793036

Intercompany Entries on Intercompany Accounts Are Created

Maconomy previously used the company from the **Standard Company** system parameter when creating budget variance entries, which caused intercompany budget entries. This error is corrected.

Defect 1194279

Incorrect Values in Job Budget Line

When you created a purchase order from a job budget and deleted a purchase order line, the **Number of Purchase Orders** and **Last Purchase Order No.** fields on the job budget would display incorrect values. This error is corrected.

Defect 1418727

Post Exchange Rate Variance on the Responsible Company

Some users always prefer to create an intercompany invoice in the base currency of the responsible company, where they post the exchange rate risk in the responsible company. The **Post Exchange Rate Variance on Responsible Company** system parameter is added to support this.

Defect 1446708

Error When Posting Invoice Reallocation of Partially Allocated Vendor Invoice

Previously, you could not disable the **Automatic posting of invoice reallocations** system parameter, reopen a reallocation after a posted partial allocation, and make changes to the allocation. This error is corrected.

Defect 1476588

System Derives Dimensions on Invoice Allocation Lines with Purchase Orders from Job

Previously, when you created vendor invoices from purchase orders with purchase order lines, the system would derive the task instead of copying them from the purchase order line to the invoice allocation lines. This error is corrected.

Application >> Job Cost

Defect 1473987**Exchange Rate Variances on Jobs**

When the **Fixed Exchange Rates in Budgets Only** system parameter is enabled, you can now select the **Post Vendor Exchange Rate Variances on Job** check box in **Single Dialogs > Job Cost > Creation > Job Information > Job Information** for jobs that have a fixed exchange rate date.

Defect 1475450**Cannot Register More than 24 Hours in Time Sheets**

Registering more than 24 hours per day was previously not possible in timesheets because it conflicted with the new check-in functionality. This error is corrected. Backward compatibility is restored and it is possible to register more than 24 hours for an employee.

Defect 1466252**Incorrect Billing Price**

The budgeted billing price on the budget was not equal to the budgeted billing price on the budget lines. This error is corrected and the budget is now in sync with the budget lines.

Defect 1467083

On jobs where the job parameter "Billing Rate Based on Actuals and ETC" of type Progress Evaluation is enabled, progress evaluation can give rise to the error "The billing price cannot be negative" (with error id A-9c9bdd68) when the job has negative registrations or direct crediting.

Defect 1452562

If the system parameter "Keep Billing Price when Changing Cost Price, Amount" is enabled, the billing price on job budget lines for amount activities is zero after update of resource allocations from People Planner even if the field "Resource Allocation Complete" is ticked.

Defect 1462231

In itemize Invoice Selection it is now possible to change Invoicing action on an already existing job entry even though a dimension is blocked.

This is consistent with Invoice Selection behavior.

Defect 1462815

The search for documents on expense sheet lines could perform quite poorly. It has been optimized.

Defect 1408684**Job Entries for Invoice Selection**

When the main job number on a sub-job is changed from one job to another, the entries on the job remain on the original job with respect to invoice selection.

Defect 1415122

If you selected a supplement on a draft invoice created from Blanket Invoicing or Blanket Invoice Selection, then the supplement field on the invoice would be blank.

Defect 1440187

After correction of this bug, if "Preferred Inv. Date" is changed at the Draft Invoice Editing stage in Blanket Invoicing, then print the invoice will pick up the exchange rate based on this date.

Defect 1443762

There was a currency conversion error when the job and invoice currency was different and "Transfer Invoicing Plan" action was used.

Now this is fixed.

Defect 1444380

In invoicing plan, on a new line, when entering a negative "Amount, Invoice Currency" the billing price became. This later lead to the "Transfer Invoicing Plan" action ending up in error: "Billing price cannot be negative"

Now this error is fixed and the billing price will never be negative.

Defect 1490787**Incorrect Employee Category in Time Sheets**

When you selected the **Keep Line** check box on a time sheet line on a previous time sheet, the employee category could be wrong on the lines created in the following time sheets if the primary employee category had changed for the employee. This error is corrected. It is also worth noting the following when changing primary employee category on an employee:

- Time sheet lines are changed going up to 12 weeks back. Time sheet lines prior to that are not changed.
- Time sheet lines that are submitted or transferred for posting are not changed. A warning displays if such lines exist when changing the primary employee category on the employee.

Application >> Trade and Misc**Defect 1099335****DTM Separation Date Not Reflected in Maconomy**

Previously, when an employee is terminated in Maconomy, future updates to the **Separation Date** field of the employee in Talent Management are not reflected in Maconomy. For example, if the employee is rehired and the **Separation Date** field is changed, the employee remained terminated. This error is corrected. In addition, the integration now looks at the **Termination Date** field in Talent Management and uses it for the **Termination Date** in Maconomy.

Defect 1107836**Resource Allocation Deletion Not Shown in Maconomy**

Previously, when allocations to the outlay budget lines are removed in People Planner, these still remain in Maconomy when the resource allocations are imported. This error is corrected.

BPM**Defect 1492141****UKMTD: Box 1 is also filled in for a UK Company to EU Customer Invoices transaction**

Previously, Box 1 (VAT Due Sales) is being filled out on customer invoices from a UK company to an EU member state customer. This should not be the case following post BREXIT rules. This error has been fixed.

Defect 1334863**UK Tax Submissions: Incorrect Warning for Blank Company Tax No.**

Previously, when you submitted a UK Tax Submission with a blank **Company Tax No.** field, a warning message displayed to inform you that the company must have a tax code to use the VAT Submission functionality. This error is corrected. The warning message now requires you to fill out the **Company Tax No.** field.

Defect 1444978**NSAF-T Only Displays Global Accounts**

When you selected **Local** in the Chart of Accounts Type prompt, the customer and supplier AccountID and GeneralLedgerAccountID in the XML file incorrectly used the global account number. This error is corrected such that that the local account number displays if you select **Local**.

Defect 1440687

UKMTD: Box 1 Missing From Tax Details Tab For Customer Invoice Transactions

In the Tax Details tab of the UK Tax Submissions report in Webi, Box 1 did not previously populate even if it was included in the Data Export and Submission History tab. The system should populate Box 1 when a transaction is a Customer Invoice with Goods or Services populated in Tax Popup 1. This error is corrected.

Defect 1441799

KNOWN ISSUE: (2.4.5 CU22, 2.4.6 CU4, 2.4.7 CU2, 2.5CU16, 2.5.1CU6, 2.5.2CU1)

SIE: File Includes Accounts Not Part of the Selection Criteria/Period

Some SIE files show accounts even if they are not part of the selection criteria/period.

Defect 1416944**UKMTD: Internal Error When Selection Criteria Exceeds the Fiscal Year**

If the date interval in the selection criteria was 366 days or more, a null pointer exception error displayed when you used the **Get VAT Obligations** action. This error is corrected. The system displays a 400 Bad Request error message pulled from the HMRC response site.

Defect 1434531**UKMTD: Missing Warning Message in UK Tax Submissions**

Previously, no warning message displayed even if there is a missing **Tax Popup** field setup in the Tax Codes. This error is corrected. A warning now displays when you click on the **Get VAT Obligations** action and you can find the details on which tax code is missing Tax Popup setup in the logs.

Defect 1435157**UKMTD: Dual Errors in UK Tax Submissions**

Previously, when you used the **Get VAT Obligations** or **Get VAT Data** action, the system simultaneously displayed two error messages in relation to the following issues:

- No Tax Reporting Unit in the Selection Criteria
- Missing Country Code setup for Companies
- Missing Country Code setup for Customers
- Missing Country Code setup for Vendors

This error is corrected.

Defect 1437296**Incompatible Objects in Aggregate Navigation in Finance Universe**

There were some objects that were not added in the aggregate navigation, which resulted to incorrect SQL generation. This error is corrected.

Defect 1419358**Incorrect Join in Finance Universe Between FINANCEENTRY and EXFISCALYEARPERIOD**

Previously, FINANCEENTRY and EXFISCALYEARPERIOD table had incorrect joins, which could affect performance. This error is corrected.

Defect 1419735**Context Errors on New Standard Dimensions in the Finance Universe**

Some of the new standard dimensions were previously excluded from contexts, which could generate incorrect results if Specification 4-10 or Local Spec. 4-10 were included for company dimensions. This error is corrected.

Defect 1355637**Profit and Loss, Periodic Report Does Not Display Amounts in Thousands**

Previously, when you run the Profit and Loss, Periodic report with the Use Reporting Currency prompt set to **Yes**, the amounts in the Budget columns did not display in thousands. This could cause confusion as the report should always display figures in thousands. This error is corrected.

Defect 1395502**Changes in Equity: Incorrect Entries in the Report**

The Changes in Equity report showed incorrect figures when an odd fiscal year was setup and used. This error is corrected.

Defect 1399217**UK MTD: Error on G/L Transactions Without Vendor Numbers**

Previously, an error message displayed frequently when G/L transactions did not have vendor numbers assigned to them. This error is corrected.

For G/L transactions that need to be part of MTD filing on boxes 4,7,9 and RCM boxes 1,4,7,9, we recommend that you include a **Vendor Reference No.** in each of your transaction.

Defect 1462940**Utilization PDF Report Retrieves Data for All Companies**

The Utilization PDF reports did not previously filter the data based on the Employee Company No. prompt from the Workspace Client. This error is corrected.

Defect 1463239

Time Sheet Reports Show Incorrect Results

The following Time Sheet reports displayed incorrect data in the Fixed Hours column when the Workspace Client link to PDF was invoked for the PSO solution:

- Time Sheet Overview Report
- Time Sheet Status, By Day
- Time Sheet Status, By Week
- Unsubmitted Time

This error is corrected.

Defect 1457889**Incorrect Join Between OPPORTUNITY_S Fact and SPECIFICATION1 Tables**

The join between OPPORTUNITY_S fact and SPECIFICATION1 tables in the Opportunity universe was incorrect. As a result, the Opportunities, Sales Pipeline, and Sales Pipeline by Contact Company reports did not retrieve any data when the Specification 1 Name and Description objects are added. This error is corrected.

Defect 1460905**UKMTD: Null Error When Executing Get VAT Data Action for CPA Solution**

Previously, when you used the **Get VAT Data** action, the report execution failed and a null error occurred in the CPA solution. This error is corrected.

Defect 1452508**Incorrect Object Definition in Finance Universe**

Previously, the Current Fiscal Year-Period and First Year-Period of Fiscal Year objects in Finance Universe had incorrect SQL definition. This is corrected.

Defect 1468702**ETL Upgrade Error Due to Inconsistent Data Types for Transaction Number**

In the earlier release of 2.5, we changed the data types of some of the fields in Maconomy. The data type for the **Transaction Number** field in JobInvoiceLine was changed from integer to string. However, this was not done in the ETL solution. An error occurred if the data contained letters, which are incompatible with integers. This error is corrected. When you upgrade from older versions to 2.5 in ETL, the data type for TransactionNumber in F_JOB_INVOICE_LINE table is changed from INT to STRING.

Defect 1483604**Incorrect Join Between CompanyInformation_D and Company Dimensions**

The COMPANYINFORMATION_D, COMPANYCUSTOMER_D, and COMPANYVENDOR_D joins to their company dimensions were previously incorrect. As a result, the query displayed blank columns if there were blank dimensions. This error is corrected.

Defect 1483973**Incorrect Joins on EXFISCALYEARPERIOD**

The joins on EXFISCALYEARPERIOD in Finance universe were previously incorrect and did not index, which affected performance. This error is corrected.

Technology >> Back End**Defect 1470738**

MScript scripts executed through the MaconomyServer command-line interface would not get their Maconomy user session removed if they only called 'deletesession()', instead of explicitly calling 'maconomy::logout()' first.

This has now been fixed so the session deletion includes an automatic logout of the user session, just like it does for CGI-based MScript script execution.

Defect 1422453

A number of places in Maconomy contain date and time fields that are supposed to show date and time information derived from user's local timezone. However, due to a defect, server's default timezone was always used to calculate this information. This defect has now been fixed.

Technology >> Back End >> Server**Defect 1463343****Network Login for Blocked Users and Users with Expired Password**

It was possible to perform a network login as a Maconomy user that was outside its validity period. All subsequent attempts to use this login session would still fail as expected because of the invalid user status, but the original login should fail as well.

For users with expired password the login sessions created by a network login were effectively read-only, only granting the user access to the Change Password dialog. The status of the user's password is not relevant for a login session created through a network login, so this has now been corrected so the users have access according to their access control settings.

Technology >> Front End >> iAccess**Defect 1465124****Budgeting Workspace Did Not Allow Users to Create the First Budget for a Job**

Browsers: Chrome, Safari, and Firefox

The Budgeting workspace in iAccess would not let users create a budget for any job without an existing working, baseline, or contract budget. This is now corrected.

Touch

Defect 1473276

Unable to Delete Receipts with Space

Previously, when you use Touch on an iOS device, you cannot delete a receipt with a space in the receipt name on the **Expense Sheet** screen. This error is corrected.

Defect 1479092

Open In Setting Change Causes Missing Loading Spinner

From the Open In setting on the **Settings** screen, you can select a default screen when you open Delttek Touch. If you select a screen other than the **Timesheet** screen and log out of the application then log back in, the loading spinner disappears from all actions. This error is corrected.

Defect 1485854

Incorrect Last Day on Date Pickers

Previously, the last day of all the months are the same in the Date Picker on all Touch screens. This error is corrected.

Defect 1487123

Read-Only Unit Price Field for Expense and Mileage

Previously, the **Unit Price** field on the **Expense Sheet Line** and **Mileage Sheet Line** screens are only editable by default. You can now customize the field and other amount fields from editable to read-only. To change an amount field to read-only, add the following code to the custom layout file:

```

Defect 1487408

Blocked Touch Users Able to Login

Previously, a blocked Touch user on the Users workspace in the Workspace Client can still log in on Touch. The defect affected blocked employees using Touch 3.4 (and higher). This error is corrected.

Defect 1491672

Editable Purchase Order Requisitioner Field

On the **Purchase Order** screen, you can only view the purchase orders you are a requisitioner for. Thus, the **Requisitioner** field should always display your employee name. When the field is editable, however, you can select a different employee and the purchase order moves to that employee's purchase orders. As a result, you cannot view the purchase order on your list anymore. The **Requisitioner** field is now read-only to ensure that the purchase order remains on your list.
