Enhancements

A new link has been added from the Actions menu in **Manage > Purchase Orders** that will allow for opening and printing the Purchase Order with the user's customization.

Corrections

The following issues have been corrected in this release:

- **Defect 1763924:** Some users experienced the error *SerializationException: Unable to find assembly 'AjeraClient, Version=9.70.3.0, Culture=neutral, PublicKeyToken=null'* when trying to print Timesheets, Expense Reports and Purchase Orders from the browser.
- **Defect 1764042:** For the **941 Preparation** report, additional Medicare Subject to and Withheld amounts were not being calculated based on the actual amounts withheld.
- **Defect 1762264:** The **941 Preparation** report showed a line for each employee, without their name, rather than showing a total line for the pay period.
- **Defect 1813249:** When running the **941 Preparation** report, you may have encountered the error *Divide by zero error encountered. The statement has been terminated.*

- **Defect 1696765:** Rejecting a single timesheet entry in the **Manage > Project Time Approval** window would reject all entries on that timesheet and change the notes for each entry to match the rejected entry.
- **Defect 1751693:** Browser-based expense reports were limiting manually entered unit rates to two decimal places beyond zero.
- **Defect 1753512:** In the **Manage Projects** task widget, Adjustment Phases were not shown.
- **Defect 1757868:** Projects with more than 500 phases were not shown in their entirety in the **Manage Projects** task widget.
- **Defect 1768054:** Restricting Activity Types for Time and Expense entries on phases in the **Project Command Center** did not restrict these phases on browser-based Timesheets or Expense Reports.

CRM Enhancements

- When a project is closed in Ajera, the **Sync to CRM** check box in the Project Command Center will stay selected. The project will then be included in the next sync to CRM. After the project syncs to CRM for the final time, the **Sync to CRM** check box will be unselected. Prior to this release, the **Sync to CRM** option was unselected when the project was closed.

Note: The **Sync to CRM** option can be reselected in the Project Command Center if further changes on the closed project are needed. It will only be included when **Sync to Closed Projects** is selected during a manual sync.

Corrections

The following issues have been corrected in this release:

- **Defect 591966:** On the 941 Preparation report, the Medicare .9% Withholding column was reporting an incorrect amount.
- **Defect 1633715:** *CRM only:* When an Ajera project was marked to sync to CRM, the long name was not populated in Vantagepoint if the Ajera project description was 40 characters or less.
- **Defect 1724137:** In **Manage > Timesheets**, you may have encountered an error message when trying to submit more than 200 timesheets at one time. Now when you're submitting more than 50 timesheets at one time, Ajera will notify you that the submission process may take extra time.
- **Defect 1740135:** In **Manage > Timesheets**, you may have encountered the error *The incoming request has too many parameters. The server supports a maximum of 2100 parameters* when trying to enter time.
- **Defect 1742072:** After upgrading to version 9.70.00, amount fields in Manage menu tasks and task widget amount fields were being limited to nine characters.
- **Defect 1744754:** In **Manage > Bank Register > Reconcile** tab, the Bank Feed Detail list was displaying items from the first bank account loaded, even after a new bank account had been selected. This also allowed for matching of the same imported detail item on multiple bank entries, which resulted in an error of "Table doesn't have a primary key."
- **Defect 1744665:** On the Manage Projects task widget, when a project had multiple invoice groups, the amount columns such as Billed, Spent, and Cost, were displaying inflated totals at the project level.
- **Defect 1757047:** When a user would print a Purchase Order from either **Manage > Purchase Orders** or the Purchase Order Widget, the default set by the user was not being used for the printed Purchase Order.

- **Defect 1738647:** Some tasks on the **Manage** menu and some dashboard widgets were not rendering when a project or phase's description and ID in the Project Command Center equaled 80 or more characters and you may have encountered the error *SqlException: String or binary data would be truncated. The statement has been terminated.*

Introducing the Manage Projects Task Widget

With the new Manage Project task widget, you are now able to manage a project's reported percent complete, estimated start, completion dates, and notes directly from a dashboard eliminating the need to navigate to the Project Command Center to enter this information.

With this new feature, you can now roll up reported percent complete from the resource level in addition to phases using both the Manage Projects task widget and in the Project Command Center.

Introducing Automated Bank Feed

With Automated Bank Feed, the repetitive task of reconciling bank registers becomes as easy as a quick review. By partnering with Plaid, bank entries from your bank are automatically and securely imported as bank feed items in Ajera and can be matched to your existing Ajera bank entries. This automated bank feed gives you a full and accurate picture of your corporate finances in Ajera.

With this new feature, there are two new gallery widgets available:

- Bank Feed Log
- Bank Feed Detail

These widgets report the syncing details for the Bank Feed integration with Plaid. View the Bank Feed Log information as well as the associated Bank Feed details. Easily identify Bank Feed logs that fail with conditional formatting applied to the message in the Bank Feed Log widget.

State Tax Changes

Idaho (IDSWH)	Effective date: 06/15/22 The Idaho Child Tax Credit Allowance increased to \$3,417 annually from \$3,154. The tax rate for supplemental payments decreased to 6% from 6.5%.

Technology Changes

- With this release, Ajera now requires a minimum of .NET Framework 4.8 to be installed on your Ajera server. If your server does not have the correct .NET Framework version, you will be unable to

complete the Ajera update. Please refer to the [Ajera 9 Hardware and Software Requirements guide](#) for more information.

- **REMINDER:** Microsoft ended support for Windows Server 2008 R2 in January 14, 2020. This means this operating system will no longer receive security patches and updates after January 14th, making them prone to attacks. Deltek will no longer support the Windows Server 2008 R2 operating system. With this change:
 - Servers will need to be upgraded to Microsoft Windows Server 2012 or higher with Microsoft .NET Framework 4.8 or later.

Enhancements

CRM enhancements

- When closing a project in Ajera, the **Sync to CRM** option will be unchecked and the project will sync to CRM one final time. The **Sync to CRM** option can be reselected in the Project Command Center if further changes on the closed project are needed. It will only be included when **Sync to Closed Projects** is selected during a manual sync.
- When a project is created in Ajera from CRM, the Estimated Start Date will be filled in with the milestone estimated start date from the project in CRM. When the project is synced from Ajera to CRM, the estimated start date in CRM will be update with the changes from Ajera.

Note:	If the date is blank in Ajera and there is a value in CRM, the value in CRM will not be blanked out.

Other enhancements

- You can now print from Ajera's browser based tasks, such as **Manage > Timesheets**, **Manage > Expense Reports**, **Manage > Purchase Orders**, and the Purchase Order Task widget without needing to use ClickOnce or .NET.
- In **Manage > Expense Reports**, you can now create a new expense report row by copying an existing expense report row.
- In **Manage > Client Invoices**, RPC and RPC Date have been added as optional columns on the following tabs:
 - Percent Complete
 - Unit Price
 - Fixed Fee
 - Percent of Construction

These columns will report the phase reported percent complete (RPC) and RPC date from the Project Command Center or Project Task Widget.

- In **Setup > Employees**, employee gender options have been expanded to include Nonbinary.
- With this release, the integration with Collaboration has been removed.

Note :	You will need to go through and manually remove any Collaboration dashboards, tabs, or widgets that exist within Ajera.

Correction

The following issue has been corrected in this release:

- **Defect 1711827:** In the Edit Client Invoice grid, the Fixed Fee tab was sorting the Phase/Activity Type incorrectly.
